The case was discussed in 704th SEIAA meeting dtd 14.02.2022 and it is decided that:-

" As per above recommendation today the case was scheduled for discussion and recorded that: As per the submitted report By C.E. WRD, it is very much clear that they have carried out the partial construction work. Hence the project falls under the violation of the EIA notification 2006. For the Environmental clearance of the violation project the Ministry issued a Standard Operating Procedure dated 07th July 2021 for identification and handling of violation cases under EIA Notification 2006. The SoP was challenged in the Madurai Bench of the High Court of Madras in the matter W.P.(MD) No. 11757 of 2021 titled Fatima Vs Union of India and was interim stayed vide order dated 15th July 2021.

Vide office memorandum dated 28.01.2022 issued by MoEF &CC, GoI the SoP has come into the force and the violation projects have to be considered accordingly.

In context of above, it is decided that the case no. 5584/2017 is hereby closed and PP should apply afresh as per as per procedure laid down in the said SoP."

In the light of above you are hereby informed that the Authority has decided to close the case and you should apply online afresh on Parivesh portal.
