With reference to above, prior EC was issued to you vide letter no. 4574 dated 02.12.2016 with specific condition no. 1 as per decision of 385th SEIAA meeting dated 16.11.2016.

The case was also discussed in 418th SEIAA meeting dtd 23.03.2017 and decided to issue corrigendum for condition no.1 and it has been recorded that

".....After detailed discussions, it has been decided to issue a corrigendum wherein the ECs issued in following 48 sand mining cases after the filing of the case OA No. 404/2016 modifying the status of the condition in consonance with the interim orders of the Hon'ble NGT and it should be read as "This EC will be subject to the Hon'ble NGT, Principal Bench, New Delhi final orders in OA No. 404/2016". Any interim directives issued by the Hon'ble NGT in this particular case shall be obligatory on the PP."

In view of above, you are hereby informed that the specific condition no.1 given in EC letter will now be read as that this EC will be subject to the Hon'ble NGT, Principal Bench, New Delhi final orders in OA No. 404/2016. Any interim directives issued by the Hon'ble NGT in this particular case shall be obligatory on the PP.


