During the re-examination of the case in, it was found that the area mentioned in earlier issued EC, approved mining plan and transferred EC letter etc. is 5.666 ha although due to typographically error in EC letter, it is mentioned as 5.066 ha in place of 5.666 ha.

After detailed discussion, it is decided that the Transfer of Prior Environmental Clearance letter issued by SEIAA for area 5.666 ha shall be read as 5.066 ha. All the conditions mentioned in the EC issued dtd. 23.03.2020 shall remain unchanged. Copy to all concerned.
