After detailed discussions, it has been decided to issue a corrigendum wherein the ECs issued in following 48 sand mining cases after the filing of the case OA No. 404/2016 modifying the status of the condition in consonance with the interim orders of the Hon'ble NGT and it should be read as "This EC will be subject to the Hon'ble NGT, Principal Bench, New Delhi final orders in OA No. 404/2016". Any interim directives issued by the Hon'ble NGT in this particular case shall be obligatory on the PP."
