With reference to above, Letter was issued to you vide letter no. 5572 dated 10.03.2017 in which condition given as per decision of 413<sup>th</sup> SEIAA meeting dtd. 03.03.2017.

"..... However the mining activity shall not commence at the mining site till the final outcome of Case No. 404/2016 under hearing with the Hon'ble NGT (Principal Bench) New Delhi. Mining Officer, Hoshangabad shall be responsible to oversee that PP or his representative shall adhere to this condition strictly"

The case was also discussed in 418<sup>th</sup> SEIAA meeting dtd 23.03.2017 and decided to issue corrigendum for condition and it has been recorded that .....

".....After detailed discussions, it has been decided to issue a corrigendum wherein the ECs issued in following 48 sand mining cases after the filing of the case OA No. 404/2016 modifying the status of the condition in consonance with the interim orders of the Hon'ble NGT and it should be read as "This EC will be subject to the Hon'ble NGT, Principal Bench, New Delhi final orders in OA No. 404/2016". Any interim directives issued by the Hon'ble NGT in this particular case shall be obligatory on the PP."

In view of above, you are hereby informed that the condition given in letter dated 10.03.2017 will now be read as that this EC will be subject to the Hon'ble NGT, Principal Bench, New Delhi final orders in OA No. 404/2016. Any interim directives issued by the Hon'ble NGT in this particular case shall be obligatory on the PP.


