Limited, Bhopal C/o Reliable House, A-6, Kohefiza, Indore Road, Bhopal (MP)**".

The corrigendum should be read along with the original EC issued vide letter dtd 12.11.12. All the conditions mentioned in the prior EC (dtd 12.11.12) shall remain the same.
