
The case was discussed in 520th SEIAA meeting dtd 15.01.2019 and it has been recorded that.....

This case was discussed in 337th SEAC meeting dated 01.01.19, and it was recorded that :

"Today, neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Earlier PP was also absent in the 328th SEAC meeting dated 08/09/2018, 312th SEAC meeting dated 17/04/2018 & 309th SEAC meeting dated 23/03/2018. Committee decided that since sufficient opportunities have been given to the PP for appraisal and consideration of the project wherein PP remain absent, the case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project".

As per above recommendation of SEAC, it has been decided to delist the case on the condition that if PP intends to present the case in SEIAA, it will then be relisted for appraisal. Copy to PP and all concerned.

As per above decision, the case is hereby delisted and shall be liable for relisting if PP intends to present the case in SEIAA.


