
The case was discussed in 548th SEIAA meeting dtd 22.05.2019 and it has been recorded that

Dhar, MP – 454665, Stone Quarry in an area of 2.00 ha. (14,559 cum per annum) (Khasra No. 1/1), Village - Nindwaniya, Tehsil - Badnawar, Dist. Dhar (MP) are very close proximity/ overlapping with the actual lease which was showed by the PP. The PP was asked to submit revised Form -1 and accordingly revised coordinates in the mining plan duly verified by the competent authority and this case may be sent to SEIAA for delisting..


In view of the above, you are informed that the case is hereby delisted. PP intends to present the case in SEIAA, it will then be relisted for appraisal.
