

Committee decided that since sufficient opportunities has been given to the PP for appraisal of their case but PP remains absent thus committee decided that case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project."*


As per the above decision, you are hereby informed that your case is delisted and liable for relisting if PP intends to present the case in SEIAA.
