
The case was discussed in 523rd SEIAA meeting dtd.15.2.2019 and it was recorded that.....

The case was discussed in 340th SEIAA meeting dtd 30.01.2019 and it was recorded that :-

"Committee observed that two opportunities were given to PP submission of any clarification on their part but PP remains absent. Committee referred the documents sent by SEIAA vide letter dated 03.07.2018 and the revised DFO certificate issued vide letter no. 1636 dated 04/05/2018. Committee observed that as per revised certificate issued by DFO, now the lease lies within the forest boundary and so far PP has not submitted NOC of Commissioner Level committee. Thus in the present circumstances, committee recommends that the EC may be cancelled."

As per above recommendation of SEAC, it has been decided to cancel the prior EC. Copy to PP and all concerned.


