"The prior EC was issued to Shri Kailash Chandra Gupta, M/s Shiva Corporation India Pvt. Ltd., 312, Ganpati Plaza, MIG Road, District-Jaipur (Raj.) vide Letter No.719/SEIAA/18 dtd.18.04.2016 for an area of 12.232 ha. at Village - Hatnoura, Tehsil-Dabra, District-Gwalior (MP).

As per New Sand Mine Policy 2017, Mineral Resources Department, Govt. of M.P. has allotted/transferred non-operational sand mines to gram panchayat/ local body vide letter No. F-19-26/2017/12/1 dated 11.01.2018 and modification letter No. F-19-26/2017/12/1 dated 9.2.18. PP (Gram Panchayat, **Hathnora,,Gwalior**) has requested Collector, Gwalior vide letter No. nil dated **5.03.2019** to make amendment in the Prior EC letter by changing the name of PP of the mining project in the name of Gram Panchayat, Hathnora,, District -Gwalior. The above application has also been forwarded by Mining Division of **Collector Office, Gwalior** to SEIAA for transfer of prior EC in the name of Gram Panchayat, **Hathnora, Gwalior**, vide letter no. क्यू./3/मा.रा./रेत नीति/2017/6274 dtd.5.3.2019.

PP (Gram Panchayat, **Hathnora, Gwalior**) has submitted the following documents in support of his request:

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 18.04.2016 in favour of Sarpanch Gram Panchayat, Hathnora, District-Gwalior in the place Shri Kailash Chandra Gupta, M/s Shiva Corporation India Pvt. Ltd., 312, Ganpati Plaza, MIG Road, District-Jaipur (Raj.) for Sand Quarry in (Opencast Manual Method) in an area of 12.232 ha. for production capacity of 73,392 cum/year at Khasra No. 1459 at Village-Hatnoura, Tehsil-Dabra, District-Gwalior (MP) on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
