Case No 4377/2015: Prior Environment Clearance for **Sand Quarry** (Open cast manual method) in an area of 21.940 ha. for production capacity of 1,31,640 cum/year at Khasra no.-718, Village-Gajapur, Tehsil-Dabra, District-Gwalior (MP) by Sarpanch, Gram Panchayat, **Ajaygarh,Gwalior**, Tehsil-Dabra District-Gwalior (MP).

The case was discussed in 536th SEIAA meeting dtd.9.04.2019 and it was recorded that.....

"The prior EC was issued to Shri Atul Gondal, M/s A.D. Agro Foods Private Ltd., Nehru Ward, Pipariya, District-Hoshangabad (MP)-477001 vide Letter No.5618 /SEIAA/17 dtd.14.03.2017 & Corrigendum issued vide Letter No.252 /SEIAA/17 dtd.13.04.2017 for an area of 21.940 ha. at Village - Gajapur, Tehsil-Dabra, District-Gwalior.

As per New Sand Mine Policy 2017, Mineral Resources Department, Govt. of M.P. has allotted/transferred non-operational sand mines to gram panchayat/ local body vide letter No. F-19-26/2017/12/1 dated 11.01.2018 and modification letter No. F-19-26/2017/12/1 dated 9.2.18. PP (Gram Panchayat **Ajaygarh,Gwalior**.) has requested Collector, Gwalior vide letter No. nil dated **5.03.2019** to make amendment in the Prior EC letter by changing the name of PP of the mining project in the name of Gram Panchayat, **Ajaygarh**, District -Gwalior. The above application has also been forwarded by MP State Mining corporation to SEIAA for transfer of prior EC in the name of Gram Panchayat, Ajaygarh, Gwalior, vide letter no. 949 dtd.25.2.2019.

PP (Gram Panchayat, **Ajaygarh,Gwalior**) has submitted the following documents in support of his request:

1. Application of Sarpanch, Gram Panchayat **Ajaygarh, Gwalior** for transfer of Prior EC in favour of the Gram Panchayat **Ajaygarh, Gwalior**.
2. No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of Gram Panchayat **Ajaygarh, District -Gwalior**.
3. Notarised affidavit of Sarpanch/Secretary, Gram Panchayat **Ajaygarh,Gwalior** mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
4. Lease transfer order issued by Office of Collector (Mining Division) to Gram Panchayat, **Ajaygarh, Gwalior** vide letter No. क्यू./3/मा.रा./रेत खदान 2019/6299 dated **6.3.2019**.
5. Copy of Prior EC issued by MPSEIAA vide letter no. 5618/SEIAA/17 dtd.14.3.17 & Corrigendum issued vide Letter No. 252/SEIAA/17 dtd.13.04.2017.

6. NOC of State Mining Corporation for transfer of EC in the name of Gram Panchayat, vide letter no. रेत /2017-18 /1069 dated 13.2.2018.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

11. Transferability of Environmental Clearance (EC):


A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 14.03.2017 & Corrigendum issued vide Letter No. 252/SEIAA/17 dtd.13.04.2017 in favour of Sarpanch Gram Panchayat, Ajaygarh, District-Gwalior in the place Shri Atul Gondal, M/s A.D. Agro Foods Private Ltd., Nehru Ward, Pipariya, District-Hoshangabad (MP)-477001. for Sand Quarry in (Opencast Manual Method) in an area of 21.940 ha. for production capacity of 1,31,640 cum/year at Khasra No. 718 at Village-Gajapur, Tehsil-Dabra, District-Gwalior (MP) on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. Copy to PP and all concerned.

Agro Foods Private Ltd., Nehru Ward, Pipariya, District-Hoshangabad (MP)-477001 vide letter no. 5618 /SEIAA/17 dtd.14.03.2017 & Corrigendum issued vide Letter No.252 /SEIAA/17 dtd.13.04.2017 for production capacity 1,31,640 m³/year at Khasra no. 718, Village-Gajapur, Tehsil-Dabra, District-Gwalior (MP) is hereby transferred to Sarpanch, Gram Panchayat, Ajaygarh Tehsil-Dabra District-Gwalior on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.


