**Sub:- Case No. 5127/2016** Prior Environment Clearance for River Sand Quarry(Open cast manual method) in an area of 11.00 ha. for production capacity of 1,65,000 cum/year at Khasra no.-118/1, Village-Barandua, Tehsil-Hoshangabad, District-Hoshangabad (MP) by, Sarpanch, Gram Panchayat, Talnagari, District -Hoshangabad

The case was discussed in 515<sup>th</sup> SEIAA meeting dtd 19.12.2018 and it was recorded that.....

"The prior EC was issued to M/s Shiva Corporation India Pvt. Ltd. Sub Lessee of MPSCML, Shri Jitendra Singh, 312, Ganpati Plaza, M.I. Road, Jaipur (RJ)-470007, vide Letter No. 1394 dtd. 10.05.2016 for an area of 11.00 ha. at Village-Barandua, Tehsil-Hoshangabad, District-Hoshangabad (MP).

As per New Sand Mine Policy 2017, Mineral Resources Department, Govt. of M.P. has allotted/transferred non-operational sand mines to gram panchayat/ local body vide letter No. F-19-26/2017/12/1 dated 23.11.2017 and modification letter No. F-19-26/2017/12/1 dated 9.02.2018. PP (Gram Panchayat, Talnagari, Hoshangabad) has requested Collector, Hoshangabad to make amendment in the Prior EC letter by changing the name of PP of the mining project in the name of Gram Panchayat, Talnagari, Hoshangabad. The above application has been forwarded by Mining Division of Collector Office, Hoshangabad to SEIAA for transfer of prior EC in the name of Gram Panchayat, Talnagari, Hoshangabad vide letter 1834/रेत नीति 2017 / dated 23.01.2018

PP (Gram Panchayat, Talnagari, Hoshangabad) has submitted the following documents in support of his request:

1. Application of Sarpanch, Gram Panchayat, Talnagari, Hoshangabad for transfer of Prior EC in favour of the Gram Panchayat, Talnagari, Hoshangabad.
2. No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of Gram Panchayat, Talnagari, Hoshangabad.
3. Notarised affidavit of Sarpanch/Secretary, Gram Panchayat, Talnagari, Hoshangabad mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
4. Lease transfer order issued by Office of Collector (Mining Division) to Gram Panchayat, Talnagari, Hoshangabad vide letter No. 1834 dtd 23.01.2018.
5. Copy of Prior EC issued by MPSEIAA vide letter No. 1394 dtd. 10. 05.2016.
6. NOC of State Mining Corporation for transfer of EC in the name of Gram Panchayat, vide letter no रेत /2017-18 /791 dated 07.2.2018 & letter no रेत /2017-18 /1069 dated 13.2.2018.


As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

**11. Transferability of Environmental Clearance (EC):**

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases


After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 10.05.2016 in favour of Sarpanch, Gram Panchayat, Talnagari, District -Hoshangabad in the place M/s Shiva Corporation India Pvt. Ltd. Sub Lessee of MPSMCL, Shri Jitendra Singh, 312, Ganpati Plaza, M.I. Road, Jaipur (RJ)-470007. for Sand Quarry (Opencast Manual Method) in an area of 11.00 ha. for production capacity of 1,65,000 cum/year at Khasra no.-118/1, Village-Barandua, Tehsil-Hoshangabad, District-Hoshangabad (M.P.) on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. Copy to PP and all concerned."

Hence, the Prior Environmental Clearance issued to M/s Shiva Corporation India Pvt. Ltd. Sub Lessee of MPSMCL, Shri Jitendra Singh, 312, Ganpati Plaza, M.I. Road, Jaipur (RJ)-470007 vide Letter No. 1394 dtd. 10. 05.2016 in an area of 11.0 ha. for production capacity of 1,65,000 cum/year at Khasra no. -118/1, Village-Barandua, Tehsil-Hoshangabad, District-Hoshangabad. is hereby transferred to Sarpanch, Gram Panchayat, Talnagari, District -Hoshangabad on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
