Case No **4060/2015**: Prior Environmental Clearance for Sand Quarry (Open cast manual method) in an area of 16.187 ha. for production capacity of 1,61,870 cum/year at Khasra no.893/852,852 at Village-Sardarnagar, Tehsil-Budhni, District-Sehore (MP) by Sarpanch, Gram Panchayat Sardarnagar, Tehsil - Budhni, District-Sehore (MP).

The case was discussed in 473th SEIAA meeting dtd.16.03.2018 and it was recorded that.....

"The prior EC was issued to Shri S.R. Traders, Sub Lessee Shri Atul Gondal, M.P. State Mining Corporation E-5, Shop No. 12, Metro Plaza, Bittan Market, Bhopal (MP)-462004. vide Letter No.10539 dtd.15.01.2016 for an area of 16.187 ha. at Village -- Sardarnagar , Tehsil-Budhni, Distt-Sehore (MP).

As per New Sand Mine Policy 2017, Mineral Resources Department, Govt. of M.P. has allotted/transferred non-operational sand mines to gram panchayat/ local body vide letter No. F-19-26/2017/12/1 dated 11.01.2018 and modification letter No. F-19-26/2017/12/1 dated 9.2.18. PP (Gram Panchayat, Sardarnagar ,Sehore) has requested Collector, Sehore to make amendment in the Prior EC letter by changing the name of PP of the mining project in the name of Gram Panchayat, Sardarnagar, Sehore. The above application has been forwarded by Collector (Mining Division), Sehore to SEIAA for transfer of prior EC in the name of Gram Panchayat,, Sardarnagar, Sehore vide letter no. Q/खनिज/2018 dtd15.03.2018.

PP (Gram Panchayat, Sardarnagar, Sehore has submitted the following documents in support of his request:

1. Application of Sarpanch, Gram Panchayat, Sardarnagar, Sehore for transfer of Prior EC in favour of the Gram Panchayat, Sardarnagar, Sehore.
2. No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of Gram Panchayat, Sardarnagar, Sehore.
3. Notarised affidavit of Sarpanch/Secretary, Gram Panchayat , Sardarnagar Sehore mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
4. Lease transfer order issued by Office of Collector (Mining Division) to Gram Panchayat, Sardarnagar, District-Sehore vide letter No. 207/खनिज/रित नीति 2017/2018 dated 18.01.2018.
5. Copy of Prior EC issued by MPSEIAA vide letter no. 10539 dtd.15.01.2016.

6. NOC of State Mining Corporation for transfer of EC in the name of Gram Panchayat, Sardarnagar, Sehore vide letter no रेत /2017-18 /1069 dated 13.2.2018.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 15.01.2016 in favour of Sarpanch Gram Panchayat, Sardarnagar, Dist. Sehore in the place Shri S.R. Traders, Sub Lessee Shri Atul Gondal, M.P. State Mining Corporation E-5, Shop No. 12, Metro Plaza, Bittan Market, Bhopal (MP)-462004. for Sand Quarry (Opencast Manual Method) in an area of 16.187 ha for production capacity of 1,61,870 cum/year at Khasra Nos. 893/852,852 at Village-- Sardarnagar,, Tehsil-Budhni, District- Sehore (MP) on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. Copy to PP and all concerned."

Hence, the Prior Environmental Clearance **issued to** Shri S.R. Traders, Sub Lessee Shri Atul Gondal, M.P. State Mining Corporation E-5, Shop No. 12, Metro Plaza, Bittan Market, Bhopal (MP)-462004. vide letter no. 10539 dtd.15.1.2016 for production capacity of 1,61,870 m³/year at Khasra nos. 893/852,852 at Village - Sardarnagar Tehsil-Budhni, Dist. Sehore (MP) is hereby transferred to Sarpanch, Gram Panchayat Sardarnagar, Tehsil - Budhni, District-Sehore on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
