The case was discussed in 468<sup>th</sup> SEIAA meeting dtd 9.02.2018 & 471<sup>th</sup> SEIAA meeting dtd 27.02.2018 and it was recorded that.....

" The prior EC was issued to Shri Shri Omprakash S/o Radhakrishan Jat, Proprietor, Village - Panthpiplai, Tehsil & Distt. Ujjain (MP) – 457779, vide Letter No. 3001 dtd. 05.08.2015 for an area of 9.710 ha. at Village- Sewarkhedi, Tehsil & Distt. Ujjain. (MP)

As per New Sand Mine Policy 2017, Mineral Resources Department, Govt. of M.P. has allotted/transferred non-operational sand mines to gram panchayat/ local body vide letter No. F-19-26/2017/12/1 dated 23.11.2017 and modification letter No. F-19-26/2017/12/1 dated 9.2.18. PP (Gram Panchayat, Aalampur Udana, Ujjain) has requested Collector, Ujjain vide letter No. nil dated 15.01.2018 to make amendment in the Prior EC letter by changing the name of PP of the mining project in the name of Gram Panchayat, Aalampur Udana, Ujjain. The above application has been forwarded by Mining Division of Collector Office, Ujjain to SEIAA for transfer of prior EC in the name of Gram Panchayat, Aalampur Udana, Ujjain vide letter no. 332 dtd 25.01.2018.

PP (Gram Panchayat, Aalampur Udana, Ujjain) has submitted the following documents in support of his request:

1. Application of Sarpanch, Gram Panchayat Aalampur Udana, Ujjain for transfer of Prior EC in favour of the Gram Panchayat Aalampur Udana, Ujjain.
2. No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of Gram Panchayat Aalampur Udana, Ujjain.
3. Notarised affidavit of Sarpanch/Secretary, Gram Panchayat Aalampur Udana, Ujjain mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
4. Lease transfer order issued by Office of Collector (Mining Division) to Gram Panchayat, Aalampur Udana, Ujjain vide letter No. 34 dated 04.01.2018.
5. Copy of Prior EC issued by MPSEIAA vide letter no. 3001 dtd. 05.08.2016.
6. NOC of Director of Geology & Mining, Govt. of M.P. for transfer of EC in the name of Gram Panchayat, Aalampur Udana, Ujjain vide letter dated 03.02.2018.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 05.08.2016. in favour of Sarpanch Gram Panchayat, Aalampur Udana, Ujjain in the place Shri Shri Omprakash Jat S/o Radhakrishan Jat for Sand Mining in (Opencast Manual Method) in an area of 9.710 ha. for production capacity of 2955 cum/year at Khasra Nos. 189,190 at Village- Sewarkhedi, Tehsil & Distt. Ujjain. (MP) on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. Copy to PP and all concerned."

Hence, the Prior Environmental Clearance issued Shri Omprakash Jat S/o Radhakrishan Jat, Proprietor, Village - Panthpiplai, Tehsil & Distt. Ujjain (MP) – 457779 vide letter no. 3001 dtd. 05.08.2016 for Sand Quarry (Opencast Manual Method) in an area of 9.710 ha. for production capacity of 2955 cum/year at Khasra Nos. 189,190 at Village- Sewarkhedi, Tehsil & Distt. Ujjain (MP) is hereby transferred to Sarpanch, Gram Panchayat, Aalampur Udana, Ujjain, Tehsil & District – Ujjain on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
