## Extension of Validity Period of Environmental Clearance

The M/s Birla Corporation Ltd. (BCL) Unit Satna Cement Works submitted the online application (Online proposal no. SIA/MP/THE/5032/2009) on 28.07.2020 and requesting for extension of validity period of environmental clearance, accorded for the above mention project for further a period of three years. The environment clearance given to the project in 05.08.2013 was earlier valid for five years but was automatically extended for seven years after the EIA notification was amended by the MoEFCC in September 2016.

The matter was placed before the SEAC 486th SEAC meeting held on dated 26.02.21and 491st meeting dtd. 18.03.21 and recommended for Extension of validity period of the Environmental Clearance for 03 years.

After the recommendation of SEAC, the case was considered in 674th SEIAA meeting dtd. 07.04.2021 and observed by the authority due to non-availability of rejected coal from washery, the project of 35 MW captive thermal power plant was kept under hold for the period. Now coal block i.e. Bikram having extractable coal reserve 9.4 million tons at Shahdol, (M.P.) has allotted to PP, therefore he has capable to regular supply of high ash

coal from the said coal block and obtain reject of coal washery for operation of 35 MW captive thermal power plant from 2023.

Based on the information/clarification furnished by PP with respect to the implementation of the above mentioned thermal power project, it is decided to accept the recommendation of SEAC 491<sup>st</sup> meeting dtd. 18.03.21 and the validity period of Environmental Clearance letter issued by SEIAA vide letter no. 1420 dtd 05.08.2013 is now extended for a further period of three years till 04.08.2023 on the same terms & condition mentioned in earlier issued EC in accordance with the MoEF & CC, Gol Notification 2006 & its amendments Notification dated 14/9/2016
