Sub: Case No. 5129/2016 Prior Environment Clearance for River Sand Quarry in an area of 20.00 ha. (1,60,000 cum/year) at khasra no. 1144 at Village-Basadi, Tehsil-Badwada, District-Katni (MP) by Shri Amit Khampariya, Sub Lessee of MPASMCL, 3162, Ganga Nagar, Jabalpur (MP)-482001.

The case was discussed in 376th SEIAA meeting dtd 17.10.2016 and it has been recorded in the minutes that

"Hon'ble NGT (CZ) has directed SEIAA to review these cases in the light of the request made by Collector, Katni on account of discrepancy in providing information of cluster situation. The order No. 4 dtd. 06.10.2016 is reproduced below :-

"These two appeals were filed against the grant of EC for rivers sand, mining to the Respondent project proponent by SEIAA.

The contention of the Appellant is that in view of the letter written on 16.09.2016 by the Collector Mines District Katni M.P wherein the Collector himself has requested for a review of the grant of the EC under order dated 08.08.2016 in case of Amit Khampariya and under order dated 13.06.2016 in case of Raghav Chandak. We direct that without going into the merits of the submissions of the appellant the matter be reviewed by SEIAA and orders passed in accordance with law. Both the ECs are set aside. We make it clear that we did not decide the matter on merits and simply reiterating the orders passed by the Collector for a review by SEIAA who shall decide the matter in accordance with law.

The matter stands disposed of. All pending M.As. are also stands disposed of."

As per the above directive, the EC issued in this case is hereby cancelled and PP may be asked to apply afresh online with the modified details and as per the notification of 15.01.2016 and 01.07.2016 issued by MoEF&CC. Copy to PP and all concerned."

In view of the above compliance of judgment in appeal No. 16 & 17/2016 Hon'ble NGT (CZ) Bhopal, you are informed that the EC issued vide L.No. 3091 dtd. 08.08.2016 is hereby cancelled and PP may apply afresh online with the modified details and as per the notification of 15.01.2016 and 01.07.2016.
