**Sub:- Case No. 5243/2016** Prior Environmental Clearance for **Sand Quarry** (Opencast Manual Method) in an area of 7.229 ha. for production capacity of 65061 cum/year at Village-Kadakna, Tehsil - Kirnapur, Dist. Balaghat by **Sarpanch**, Gram Panchayat, Kadakna, District-Balaghat.

The case was discussed in 481<sup>st</sup> SEIAA meeting dtd 10.05.2018 and it was recorded that.....

" The prior EC was issued to M/s Sainik Foods Pvt. Ltd, Shri Narayan Prasad Pandey, R/o H.No. 1199, D/13, 3<sup>rd</sup> Floor, State no 13, Govindpuri, Kalkaji, New Delhi - 110019 vide Letter No. 2963 dtd. 03.08.2016 for an area of 7.229 ha. at Village- Kadakna, Tehsil - Kirnapur, Dist. Balaghat (M.P.).

As per New Sand Mine Policy 2017, Mineral Resources Department, Govt. of M.P. has allotted/transferred non-operational sand mines to gram panchayat/ local body vide letter No. F-19-26/2017/12/1 dated 23.11.2017 and modification letter No. F-19-26/2017/12/1 dated 09.02.18. PP (Gram Panchayat, Kadakna, District-Balaghat) has requested Collector, Balaghat to make amendment in the Prior EC letter by changing the name of PP of the mining project in the name of Gram Panchayat, Kadakna, District-Balaghat. The above application has been forwarded by Mining Division of Collector Office, Balaghat to SEIAA for transfer of prior EC in the name of Gram Panchayat, Kadakna, District-Balaghat vide letter no. 508 dtd 09.04.2018.

PP (Gram Panchayat, Kadakna, District-Balaghat) has submitted the following documents in support of his request:

1. Application of Sarpanch, Kadakna, District-Balaghat for transfer of Prior EC in favour of the Gram Panchayat Kadakna, District-Balaghat.
2. No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of Gram Panchayat Kadakna, District-Balaghat.
3. Notarised affidavit of Sarpanch/Secretary, Gram Panchayat Kadakna, District-Balaghat mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
4. Lease transfer order issued by Office of Collector (Mining Division) to Gram Panchayat, Kadakna, District-Balaghat vide letter No. 430 dtd 28.03.2018.
5. Copy of Prior EC issued by MPSEIAA vide letter No. 2963 dtd. 03.08.2016.
6. NOC of Director of Geology & Mining, Govt. of M.P. for transfer of EC in the name of Gram Panchayat, Kadakna, District-Balaghat vide letter dated 09.05.2018

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases



After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 03.08.2016 in favour of Sarpanch, Gram Panchayat, Kadakna, District-Balaghat in the place of M/s Sainik Foods Pvt. Ltd, Shri Narayan Prasad Pandey, R/o H.No. 1199, D/13, 3rd Floor, State no 13, Govindpuri, Kalkaji, New Delhi – 110019 on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. Copy to PP and all concerned."

Hence, the Prior Environmental Clearance issued to M/s Sainik Foods Pvt. Ltd, Shri Narayan Prasad Pandey, R/o H.No. 1199, D/13, 3rd Floor, State no 13, Govindpuri, Kalkaji, New Delhi – 110019 vide Letter No. 2963 dtd. 03.08.2016 in an area of 7.229 ha. for production capacity of 65061 cum/year at Village-Kadakna, Tehsil - Kirnapur, Dist. Balaghat is hereby transferred to Sarpanch, Gram Panchayat, Kadakna, District-Balaghat on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
