(10,800 cum/year) at khasra no. 01 at Village - Kumhariya, Tehsil - Betul, District - Katni (MP)".

Applicant M/s M/s Hotel Uma Residency, Chanakyapuri Colony, Satna (MP) has submitted the following documents in support of his request:

- No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of M/s Hotel Uma Residency, Chanakyapuri Colony, Satna (MP).
- Notarised affidavit of Sarpanch Gram Panchayat Mandai Bujurg, Janpad Panchayat Betul, Tehsil - Betul, Dist. - Betul (MP) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
- Copy of Prior EC issued by DEIAA, Dist. - Betul vide letter No. 40/DEIAA/18 dtd. 01.10.2018.
- Copy of Environmental Management Plan of M/s Hotel Uma Residency, Chanakyapuri Colony, Satna (MP).
- Copy of Approved Mining Plan with Replenishment Plan of M/s Hotel Uma Residency, Chanakyapuri Colony, Satna (MP).
- Lease transfer order issued by Mineral Resource Department to M/s Hotel Uma Residency, Chanakyapuri Colony, Satna (MP) vide letter No. 518/132/2020/12/1/ dated 06.02.2020.


As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

Para 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued by DEIAA, Betul on 01.10.2018 in favour of M/s Hotel Uma Residency, Chanakyapuri Colony, Satna (MP) in place of Sarpanch/ Sachiv Gram Panchayat Mandai Bujurg, Janpad Panchayat Betul, Tehsil - Betul, Dist. - Betul (MP) for Sand Quarry in an area of 0.700 ha. for production capacity of 10,800 cum/year at khasra no. 01 at Village - Kumhariya, Tehsil - Betul, District - Betul (MP) on the same terms & conditions and validity period under which the prior Environmental Clearance was initially granted. Copy to PP and all concerned".


