Regarding transfer of EC in the name of Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra).

The case was discussed in 663rd SEIAA meeting dtd 26.02.2021 and it has been recorded that

"The Prior EC was issued by DEIAA to Shri Jitendra Kanojiya, Resi. - Village - Shahpura, Tehsil & Dist. - Chhindwara vide Letter No. 019/DEIAA/2017 dated 28.08.2017 for an area of 5.00 ha. (4000 cum/year) at khasra no. 439/3 at Village - Badiwada, Tehsil - Chand, Dist. - Chhindwara (MP)".

Applicant Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra) has submitted the following documents in support of his request:

- a) No Objection Certificate in the form of Notarised Affidavit submitted by District Mining Officer, Chhindwara (as per OM dated 14.01.20 issued by MP-SEIAA) on behalf of previous PP Shri Jitendra Kanojiya, Resi. – Village – Shahpura, Tehsil & Dist. – Chhindwara, for transfer of EC in the name of Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Plient, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra).
- b) Notarised affidavit of Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
- c) Copy of Prior EC issued by DEIAA, Dist. Chhindwara vide DEIAA vide L.No. 019/DEIAA/2017 dated 28.08.2017.
- d) Copy of Environmental Management Plan of Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Plient, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra).

- e) Copy of Approved Mining Plan with Replenishment Plan of Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Plient, Somalwada, Wardha Road, Nagpur -440025 (Maharashtra).
- a) Lease transfer order issued by Mineral Resource Department to Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra) vide letter No. vide letter No. 1016/132/2020/12/1/ dated 18.02.2021.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

Para 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferor with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued by DEIAA Chhindwara on 28.08.2017 in the name of "Shri Jitendra Kanojiya, Resi. – Village – Shahpura, Tehsil & Dist. – Chhindwara (MP)" is hereby transferred to "Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra)." for Sand Quarry (Opencast Manual Method) in an area of 5.00 ha. for production capacity of 4000 m3 /year at Khasra no. 439/3 at Village - Badiwada, Tehsil - Chand, Dist. - Chhindwara (MP) on the same terms & conditions and validity period under which the prior Environmental Clearance was initially granted. Copy to PP and all concerned".

Hence, it was decided to transfer the Prior EC in the name of Shri Shishir Khandar, Owner R/o Samashish Bhavan, 18 Malik Complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra) with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
