The case was discussed in 650th SEIAA meeting dtd. 28.12.2020 and it was recorded that.....

- (1) It was noted that the PP had applied in Form-IM in DEIAA (Case no. 85/2018) for Prior Environmental Clearance Sand Quarry in an area of 4.950 ha. for production capacity of 6302 cum/ year at Khasra No. 503 at Village - Pipalynagar, Tehsil - Kalapipal, Dist. Shajapur (MP) by Sarpanch Gram Panchayat , Pipalynagar, Janpad Panchayat Kalapipal, District Shajapur...
- (2) The Prior Environmental Clearance letter was issued DEIAA vide L.No. 470-502/DEIAA/18 dtd.26.09.2018 in the name of " Sarpanch Gram Panchayat , Pipalynagar, Janpad Panchayat Kalapipal, District Shajapur".
- (3) It is noted that PP has requested vide no nil dtd.nil received in SEIAA office 16.12.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely " M/s Fortune Mines & Minerals, Authorized Person - Shri Ashish Kumar Shrotri, Add. H.No, 15, , Chatrapati Shivaji Colony, Chuna Bhatti, Kolar Road, Tehsil Huzur , Bhopal (M.P)" in place of "Sarpanch Gram Panchayat , Pipalynagar, Janpad Panchayat Kalapipal, District Shajapur".
- (4) It is noted that in support of his request the PP has submitted the following documents

 - ii. Notarised affidavit of M/s Fortune Mines & Minerals, Authorized Person - Shri Ashish Kumar Shrotri, Add. H.No, 15, , Chatrapati Shivaji Colony, Chuna Bhatti, Kolar Road, Tehsil Huzur , Bhopal (M.P)".mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.

- (5) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued DEIAA on 26.09.2018 in the name of " Sarpanch Gram Panchayat, Pipalynagar, Janpad Panchayat Kalapipal, District Shajapur." is hereby transferred to M/s Fortune Mines & Minerals, Authorized Person - Shri Ashish Kumar Shroti, Add. H.No. 15, , Chatrapati Shivaji Colony, Chuna Bhatti, Kolar Road, Tehsil Huzur, Bhopal (M.P) ". for Sand Quarry in an area of 4.950 ha. for production capacity of 6302 cum/ year at Khasra No. 503 at Village - Pipalynagar, Tehsil - Kalapipal, Dist. Shajapur (MP) " on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly..

Hence, the Prior Environmental Clearance issued to Sarpanch Gram Panchayat, Pipalynagar, Janpad Panchayat Kalapipal, District Shajapur., DEIAA vide L.No. 470-502/DEIAA/18 dtd.26.09.2018. for Sand Quarry in an area of 4.950 ha. for production capacity of 6302 cum/ year at Khasra No. 503 at Village - Pipalynagar, Tehsil - Kalapipal, Dist. Shajapur (MP) is hereby transferred to M/s Fortune Mines & Minerals, Authorized Person - Shri Ashish Kumar Shroti, Add. H.No. 15, , Chatrapati Shivaji Colony, Chuna Bhatti, Kolar Road, Tehsil Huzur, Bhopal (M.P). on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
