The case was discussed in 653rd SEIAA meeting dtd 08.01.2021 and it has been recorded that

"The Prior EC was issued by DEIAA, vide L.No. 232/DEIAA/16 dated 16.05.2016 in the name of Shri Raj Kumar Nema, OIC, M.P. State Mining Corporation Ltd., Sub Off., H.No. 12, Ward No. 17, Sainath Colony, Meenakshi, Hoshangabad (MP)-46100 for an area of 4.0 Ha. for production capacity of 1,20,000 cum per annum at Khasra no. 263, 283 at Village- Kasdakhurd, Tehsil - Itarsi, Dist. - Hoshangabad (MP)".

Applicant M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G) has submitted the following documents in support of his request:

- No objection letter (in form of affidavit) of Shri Raj Kumar Nema, previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G).
- No objection letter received from main leasee, MPSCMC vide letter dated 07.01.2021 mentioning that the sub-leasee has surrendered mining lease to MPSCMC vide letter dated 28.05.2019 but the MPSCMC as main leasee has Sand Mining Lease validity upto 03.08.2023 as per collector letter no. 1051/Khanij/2013 dated 12.09.2013.
- Notarised affidavit of M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
- Copy of Prior EC issued by DEIAA vide letter No. 232/DEIAA/16 dated 16.05.2016.
- Copy of Environmental Management Plan of M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G).
- Copy of Approved Mining Plan with Replenishment Plan of production capacity 66,000 cum/year in the name of M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G).

- vii. Lease transfer order issued by Mineral Resource Department to M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G) vide letter No. 5509/132/2020/12/1 dated 16.12.2020 and 08/132/2020/12/1 dated 01.01.2021.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

Para 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued by DEIAA, on 16.05.2016 in the name of "Shri Raj Kumar Nema, OIC, M.P. State Mining Corporation Ltd., Sub Off., H.No. 12, Ward No. 17, Sainath Colony, Meenakshi, Hoshangabad (MP)-46100" is hereby transferred to "M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G)" for Sand Quarry in an area of 4.0 ha. for production capacity of 66,000 cum per annum (as per approved Mining and Replenishment Plan) at Khasra No. 263, 283, Village - Kasdakhurd, Tehsil - Itarsi, Dist. - Hoshangabad (MP) on the same terms & conditions and validity period under which the prior Environmental Clearance was initially granted. Copy to PP and all concerned".

Hence, it was decided to transfer the Prior EC in the name of M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G) with the same terms & conditions under which the Prior Environmental Clearance was initially granted.
