The case was discussed in 633rd SEIAA meeting dtd 26.02.2021 and it has been recorded that

" The prior EC was issued by DEIAA to Shri Krishna Kumar Tamrakar S/o Shri Ramkhelawan Tamrakar R/o Gud Road, District - Rewa (MP) vide Letter No. 114/DEIAA/17 dated 29.09.2017 for an area of 1.263 ha for production capacity of 3450 cum/year at Khasra no. 124 at Village - Khamriya, Tehsil - Huzur, Dist. - Rewa (MP).

Applicant Shri Brajendra Dwivedi S/o Shri Udayraj Dwivedi, Village - Baijnath, Tehsil - Huzur, Dist. - Rewa (MP) - 486001 has submitted the following documents in support of his request:

No Objection Certificate in the form of Notarised Affidavit submitted by Madhvi Tamrakar W/o Late Shri Krishna Kumar Tamrakar on behalf of previous PP, Shri Krishna Kumar Tamrakar S/o Shri Ramkhelawan Tamrakar R/o Gud Road, District - Rewa for transfer of prior EC in the name of Shri Brajendra Dwivedi S/o Shri Udayraj Dwivedi, Village - Baijnath, Tehsil - Huzur, Dist. - Rewa (MP).

Notarised affidavit of Shri Brajendra Dwivedi S/o Shri Udayraj Dwivedi, Village - Baijnath, Tehsil - Huzur, Dist. - Rewa (MP) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
3. Copy of Prior EC issued by DEIAA, Dist. - Rewa vide L.No. 114/DEIAA/17 dated 29.09.2017.
4. Copy of Environmental Management Plan of Shri Brajendra Dwivedi S/o Shri Udayraj Dwivedi, Village - Baijnath, Tehsil - Huzur, Dist. - Rewa (MP).
5. Copy of Approved Mining Plan Shri Brajendra Dwivedi S/o Shri Udayraj Dwivedi, Village - Baijnath, Tehsil - Huzur, Dist. - Rewa (MP).

6. Lease transfer order issued by Office of the Collector (Mining Division) District Rewa (MP) to Shri Brajendra Dwivedi S/o Shri Udayraj Dwivedi, Village - Baijnath, Tehsil - Huzur, Dist. - Rewa (MP) vide letter No. 4146/Khanij/2018 dated 19.07.2018.


As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued by DEIAA, Dist. - Rewa on 29.09.2017 in the name of "Shri Krishna Kumar Tamrakar S/o Shri Ramkhelawan Tamrakar R/o Gud Road, District - Rewa (MP)" is hereby transferred to "Shri Brajendra Dwivedi S/o Shri Udayraj Dwivedi, Village - Baijnath, Tehsil - Huzur, Dist. - Rewa (MP)" for Burn Limestone Quarry in an area of 1.263 ha. for production capacity of 3450 cum/year at Khasra no. 124 at Village - Khamriya, Tehsil - Huzur, Dist. - Rewa (MP) on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. Copy to PP and all concerned. "


