As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

Case no. 2770/2015

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity Para 11. Transferability of Environmental Clearance (EC): to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.
