Sub:- **Case No.3005/2015** Prior Environment Clearance for Sand Quarry (Opencast Manual Method) in an area of 2.00 ha. (56,000 cum/year) at Village-Veerpura, Tehsil-Lidhora, District-Tikamgarh (MP) by **Shri Virendra Singh Jadoun, E-7/ M-708, Arera Colony, Bhopal M.P. 462016.**

The case was discussed in 614th SEIAA meeting dtd. 04.06.2020 and it was recorded that.....

- (1) It was noted that the PP had applied in Form-I for Prior Environmental Clearance of 2.0 ha. for production capacity of 56000 cum /year at Khasra no. 759 at Village- Veerpura, Tehsil-Lidhora, District-Tikamgarh by Shri Nagendra Singh, OIC, M.P. State Mining Corporation Ltd., Civil Line, Tikamgarh (MP)- 472001.
- (2) The Prior Environmental Clearance letter was issued SEIAA vide L.No. 7031/SEIAA/15 dtd.31.10.2015 in the name of " Shri Nagendra Singh, OIC, M.P. State Mining Corporation Ltd., Civil Line, Tikamgarh (MP)- 472001.
- (3) It is noted that PP has requested vide no nil dtd.05.05.2020 received in SEIAA office 05.05.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely " Shri Virendra Singh Jadon, E-7/ M-708, Arera Colony, Bhopal M.P. 462016." in place of "Shri Nagendra Singh, OIC, M.P. State Mining Corporation Ltd., Civil Line, Tikamgarh (MP)- 472001".
- (4) It is noted that in support of his request the PP has submitted the following documents
 - i. No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of Shri Virendra Singh Jadon, E-7/ M-708, Arera Colony, Bhopal M.P. 462016.
 - ii. Notarised affidavit of "Shri Nagendra Singh, OIC, M.P. State Mining Corporation Ltd. Civil Line, Tikamgarh " mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued
 - iii. Copy of Prior EC issued by SEIAA. vide L.No. 7031/SEIAA/15 dtd.31.10.2015
 - iv. Copy of Environmental Management Plan of Shri Virendra Singh Jadon, E-7/ M-708, Arera Colony, Bhopal M.P. 462016.
 - v. Copy of Approved Mining Plan with Replenishment Plan of Shri Virendra Singh Jadon, E-7/ M-708, Arera Colony, Bhopal M.P. 462016
 - vi. Lease transfer order issued by Mineral Resource Department order to of Shri Virendra Singh Jadon, E-7/ M-708, Arera Colony, Bhopal M.P. 462016, vide endt. letter No. 1579/132/2020/12/1 dated 13.03.2020.

- (5) It is noted that in EIA Notification 2006 as per **Para-11 Transferability of Environmental Clearance (EC)** there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued SEIAA on 31.10.2015 in the name of " **Shri Nagendra Singh, OIC, M.P. State Mining Corporation Ltd. Civil Line, Tikamgarh.**" is hereby transferred to **Shri Virendra Singh Jadon, E-7/ M-708, Arera Colony, Bhopal M.P. 462016-** for Sand Quarry (Open cast manual method) in an area of 2.0 ha. for production capacity of 56000 cum /year at Khasra no. 759 at Village- Veerpura, Tehsil-Lidhora, District-Tikamgarh (MP) ." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. **All concerned be informed accordingly.**

Hence, the Prior Environmental Clearance issued to **Shri Nagendra Singh, OIC, M.P. State Mining Corporation Ltd. Civil Line, Tikamgarh** vide L.No. 7039 /SEIAA/2015 dated 31.10.2015 for Sand Quarry (Open cast manual method) in an area of 2.0 ha. for production capacity of 56000 cum /year at Khasra no. 759 at Village- Veerpura, Tehsil-Lidhora, District-Tikamgarh (MP) is hereby transferred to **Shri Virendra Singh Jadon, E-7/ M-708, Arera Colony, Bhopal M.P. 462016.** on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
