
As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

Para 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 06.06.2016 in favour of Shri Ujjwal Chauhan S/o Dashrath Singh Chouhan, Santoshi Mata ward, Pandhurna, Dist. - Chhindwara (MP) in the place of Shri Raj Kumar Nema, OIC, Sub Off., M.P. State Mining Corporation Ltd., H.No. 12, Ward No. 17, Sainath Colony, Meenakshi, Hoshangabad (MP) for Sand Quarry in an area of 8.00 ha. for production capacity of 80,000 cum/year at khasra no. 1/1 to 6 & 47 at Village - Gola Malgajari (A), Tehsil - Handiya, District - Harda (MP) on the same terms & conditions, production capacity and validity period under which the prior Environmental Clearance was initially granted. Copy to PP and all concerned".

Hence, Prior Environmental Clearance for Sand Quarry (Opencast Manual Method) in an area of 8.0 ha. for production capacity of 80,000 cum/year at khasra no. 1/1 to 6 & 47 at Village - Gola Malgajari (A), Tehsil - Handiya, District - Harda (MP) issued to Shri Raj Kumar Nema, OIC, Sub Off., M.P. State Mining Corporation Ltd., H.No. 12, Ward No. 17, Sainath Colony, Meenakshi, Hoshangabad (MP) is hereby transferred to Shri Ujjwal Chauhan S/o Dashrath Singh Chouhan, Santoshi Mata ward, Pandhurna, Dist. - Chhindwara (MP) on the same terms & conditions, production capacity and valid period under which the Prior Environmental Clearance was initially granted.


