Sub:- Case No. 3305/15 Prior Environmental Clearance for River Sand Quarry (Opencast Manual Method) in an area of 16.15 ha. (1,30,000 cum/year) at khasra no. 71, 186, 631 at Village - Bahirghata, Tehsil - Barhi, District - Katni (MP) by M/s Vista Sales Pvt. The case was discussed in 603rd SEIAA meeting dtd 03.03.20 and it has been recorded that

"The Prior EC was issued by SEIAA to Sarpanch, Gram Panchayat Khirhani, Dist. – Katni (MP) vide Letter No. 2862/SEIAA/19 dated 30.03.19 for an area of 16.15 ha. (1,30,000 cum/year) at khasra no. 71, 186, 631 at Village - Bahirghata, Tehsil - Barhi, District - Katni (MP).

Applicant M/s Vista Sales Pvt. Ltd., Gala no. 216, Building no. 03 B, Rahul Mittal Industries State Kurla Road, Andheri Mumbai - 400059 (MH) has submitted the following documents in support of his request:

- a) No objection letter of Chief Executive Officer (CEO), Janpad Panchayat Badwara, Dist. Katni (MP) for transfer of prior EC in the name of M/s Vista Sales Pvt. Ltd., Gala no. 216, Building no. 03 B, Rahul Mittal Industries State Kurla Road, Andheri Mumbai - 400059 (MH).
- b) Notarised affidavit of Shri Gyanendea Kumar Mishra, CEO, Janpad Panchayat Badwara, Dist. – Katni (MP) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
- c) Copy of Prior EC issued by SEIAA vide letter No. 2862/SEIAA/19 dated 30.03.19.
- d) Copy of Environmental Management Plan of M/s Vista Sales Pvt. Ltd., Gala no. 216, Building no. 03 B, Rahul Mittal Industries State Kurla Road, Andheri Mumbai - 400059 (MH).
- e) Copy of Approved Mining Plan with Replenishment Plan of M/s Vista Sales Pvt. Ltd., Gala no. 216, Building no. 03 B, Rahul Mittal Industries State Kurla Road, Andheri Mumbai -400059 (MH).

f) Lease transfer order issued by Mineral Resource Department to M/s Vista Sales Pvt. Ltd., Gala no. 216. Building no. 03 B. Rahul Mittal Industries State Kurla Road, Andheri Mumbai - 400059 (MH) vide letter No. 864/132/2020/12/1/ dated 17.02.2020.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

Para 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 30.03.2019 in favour of M/s Vista Sales Pvt. Ltd., Gala no. 216, Building no. 03 B, Rahul Mittal Industries State Kurla Road, Andheri Mumbai - 400059 (MH) in place of Sarpanch, Gram Panchayat Khirhani, Dist. - Katni (MP) for Sand Quarry in an area of 16.15 ha. for production capacity of 1,30,000 cum/year at khasra no. 71, 186, 631 at Village - Bahirghata, Tehsil -Barhi, District - Katni (MP) on the same terms & conditions and validity period under which the prior Environmental Clearance was initially granted. Copy to PP and all concerned".

Hence, it was decided to transfer the Prior EC in the name of M/s Vista Sales Pvt. Ltd., Gala no. 216. Building no. 03 B. Rahul Mittal Industries State Kurla Road. Andheri Mumbai - 400059 (MH) with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
