Road, Fatehpur (UP)-212601 vide Letter No. 4510/SEIAA/16 dated 29.11.16 for an area of 20.243 ha. for production capacity of 2,00,000 cum/year at khasra no. 1163 at Village-Nimsadiya, Tehsil-Hoshangabad, District-Hoshangabad (MP)".*

*Applicant M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G) has submitted the following documents in support of his request:*

- No objection letter (in form of affidavit) of Shri Raj Kumar Nema, DGM (Geology), MPSCM as main leasee on behalf of previous Project Proponent as sub-leasee (to whom prior EC was granted) for transfer of prior EC in the name of M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G).
- No objection letter received from main leasee, MPSCM vide letter dated 30.12.2020 and 10.06.2020 mentioning that the mine is operating by contractor and has validity upto 31.03.2021.
- Notarised affidavit of M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
- Copy of Prior EC issued by SEIAA vide letter No. 4510/SEIAA/16 dated 29.11.16.
- Copy of Environmental Management Plan of M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G).
- Copy of Approved Mining Plan with Replenishment Plan of M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G).

- g) Lease transfer order issued by Mineral Resource Department to M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G) vide letter No. 5531/132/2020/12/1 dated 16.12.2020 and 5656/132/2020/12/1 dated 24.12.2020.


As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

Para 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued by SEIAA on 29.11.2016 in the name of "Shri Santosh Raj Dwivedi, Sub Lessee, M.P. State Mining Corporation Ltd., 235-A, Kheldar, G.T. Road, Fatehpur (UP)-212601" is hereby transferred to "M/s R.K. Transport & Constructions Ltd., 65 - A Transport Nagar Korba Distt. - Korba, (C.G)" for Sand Quarry in an area of 20.243 ha. for production capacity of 2,00,000 cum/year at khasra no. 1163 at Village-Nimsadiya, Tehsil-Hoshangabad, District-Hoshangabad (MP) on the same terms & conditions and validity period under which the prior Environmental Clearance was initially granted. Copy to PP and all concerned".


