As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

Para 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a


written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued on 10.03.2016 in favour of M/s Vista Sales Pvt. Ltd., Gala no. 216, Building no. 03 B, Rahul Mittal Industries State Kurla Road, Andheri Mumbai - 400059 (MH) in place of M/s Larsen & Toubro Ltd., Sub - Lessee of M.P. State Mining Corporation Ltd., Shri T. Ravi Patnayak, Project Manager, TC III Tower B, 7th Floor, B-Wing, Post Box 979, Manpakkam, Chennai, Tamilnadu - 600001 for Sand Quarry in an area of 7.260 ha. for production capacity of 58,080 cum/year at khasra no. 17 at Village - Ganeshpura, Tehsil - Badwara, District - Katni (MP) on the same terms & conditions and validity period under which the prior Environmental Clearance was initially granted. Copy to PP and all concerned".

Hence, Prior Environmental Clearance for Sand Quarry (Opencast Manual Method) in an area of 7.260 ha. (Production Capacity 58,080 cum/year) at khasra no. 17 at Village - Ganeshpura, Tehsil - Badwara, District - Katni (MP) issued to M/s Larsen & Toubro Ltd., Sub - Lessee of M.P. State Mining Corporation Ltd., Shri T. Ravi Patnayak, Project Manager, TC III Tower B, 7th Floor, B-Wing, Post Box 979, Manpakkam, Chennai, Tamilnadu - 600001 is hereby transferred to M/s Vista Sales Pvt. Ltd., Gala no. 216, Building no. 03 B, Rahul Mittal Industries State Kurla Road, Andheri Mumbai - 400059 (MH) on the same terms & conditions, production capacity and valid period under which the Prior Environmental Clearance was initially granted.


