- (1) It was noted that the PP had applied in Form-I for Prior Environmental Clearance of 7.183 ha. for production capacity of 340 cum/year at Khasra No.-1, 52/256 at Village-Piplya, Tehsil-Rajgarh, District-Rajgarh (MP) by **Sarpanch**, Gram Panchayat, Piplya, District-Rajgarh MP.
- (2) The Prior Environmental Clearance letter was issued SEIAA vide L.No. 1781/SEIAA/18 dtd.28.2.2018 in the name of "Sarpanch, Gram Panchayat, Piplya, District-Rajgarh MP.
- (3) It is noted that in support of his request the PP has submitted the following documents
 - i. **No objection letter (in form of affidavit)** of CEO, Janpad Panchayat Dist. - Rajgarh (MP) on behalf of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of M/s Girja Trading Company Authorized Person Shri Kameshwar Singh R/o H.No. 102 B Patel Nagar Raisen Road Bhopal, MP.
 - ii. **Notarised affidavit** of M/s Girja Trading Company Authorized Person Shri Kameshwar Singh R/o H.No. 102 B Patel Nagar Raisen Road Bhopal, MP. mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - iii. Copy of Prior EC issued by SEIAA vide letter No. 1781/SEIAA/2018 dtd 28.2.2018.
 - iv. Copy of Environmental Management Plan of M/s Girja Trading Company Authorized Person Shri Kameshwar Singh R/o H.No. 102 B Patel Nagar Raisen Road Bhopal, MP.
 - v. Copy of Approved Mining Plan with Replenishment Plan of M/s Girja Trading Company Authorized Person Shri Kameshwar Singh R/o H.No. 102 B Patel Nagar Raisen Road Bhopal, MP.
 - vi. Lease transfer order issued by **Mineral Resource Department** to M/s Girja Trading Company Authorized Person Shri Kameshwar Singh R/o H.No. 102 B Patel Nagar Raisen Road Bhopal, MP. vide letter No. 3564/132/2020/12/1 dated **31.7.2020**.

- (4) It is noted that in EIA Notification 2006 as per **Para-11 Transferability of Environmental Clearance (EC)** there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.


In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued on 28.2.2018 in the name of "**Sarpanch, Gram Panchayat, Piplya, District-Rajgarh MP**" is hereby transferred to M/s Girja Trading Company Authorized Person Shri Kameshwar Singh R/o H.No. 102 B Patel Nagar Raisen Road Bhopal, MP for **Sand Quarry in an area of 7.183 ha.** for production capacity of 340 cum/year at Khasra No.-1, 52/256 at Village-Piplya, Tehsil-Rajgarh, District-Rajgarh (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. **All concerned be informed accordingly.**
