Sub:- Case No. 4940/16 Prior Environmental Clearance for **Sand Quarry** (Opencast Manual Method) in an area of 6.00 ha. for production capacity of 1,20,000 cum/year at Khasra No.- 546, Village-Kamkomohaniya, Tehsil-Dindori, District-Dindori (MP) by Shri K.P. Singh Bhadoriya, Contractor, E-46 A, Balwant Nagar, Thatipura, Gwalior (MP).

The case was discussed in 661st SEIAA meeting dtd 17.02.2021 & 662nd SEIAA meeting dated 17.02.2021 and it has been recorded that

"The Prior Environmental Clearance letter was issued by SEIAA, vide L.No. 1402/SEIAA/16 dated 10.05.2016 in the name of "Shri Tejendra Singh, M/s Digiana Industries Pvt. Ltd., Sub Lessee of M.P. State Mining Corporation Limited, G-1, M-3, Sapna Chambers, 12/1, South Tukoganj, Indore (MP)-452001".

It is noted that PP has requested vide letter no. nil dtd. nil to transfer the Prior EC letter in the name of PP of the mining project namely Shri K.P. Singh Bhadoriya, Contractor, E-46 A, Balwant Nagar, Thatipura, Gwalior (MP).

It is noted that in support of his request the PP has submitted the following documents:

- i. No objection letter (in form of affidavit) of Shri Tejendra Singh, M/s Digiana Industries Pvt. Ltd. (to whom prior EC was granted) for transfer of prior EC in the name of Shri K.P. Singh Bhadoriya, Contractor, E-46 A, Balwant Nagar, Thatipura, Gwalior (MP).*
- ii. Notarised affidavit of Shri K.P. Singh Bhadoriya, Contractor, E-46 A, Balwant Nagar, Thatipura, Gwalior (MP) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.*
- iii. Copy of Prior EC issued by SEIAA vide letter No. 1402/SEIAA/16 dated 10.05.2016.*
- iv. Copy of Environmental Management Plan of Shri K.P. Singh Bhadoriya, Contractor, E-46 A, Balwant Nagar, Thatipura, Gwalior (MP).*
- v. Copy of Approved Mining Plan with Replenishment Plan of Shri K.P. Singh Bhadoriya, Contractor, E-46 A, Balwant Nagar, Thatipura, Gwalior (MP).*
- vi. Lease transfer order issued by Mineral Resource Department to Shri K.P. Singh Bhadoriya, Contractor, E-46 A, Balwant Nagar, Thatipura, Gwalior (MP). vide letter No. 2935/132/2020/12/1 dated 04.07.2020.*

It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

Para-11:- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance

was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above, it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by SEIAA, on 10.05.2016 in the name of "M/s Digiana Industries Pvt. Ltd., Shri Tejendra Singh, (Director) Sub Lessee of M.P. State Mining Corporation Limited, G-1, M-3, Sapna Chambers, 12/1, South Tukoganj, Indore (MP) - 452001" is hereby transferred to "Shri K.P. Singh Bhadoriya, Contractor, E-46 A, Balwant Nagar, Thatipura, Gwalior (MP)" for Sand Quarry (Opencast Manual Method) in an area of 6.00 ha. for production capacity of 1,20,000 cum/year at Khasra No.- 546, Village-Kamkomohaniya, Tehsil-Dindori, District-Dindori (MP) on the same terms & conditions and validity period under which the prior Environmental Clearance was initially granted"

In view of above, prior EC issued to M/s Digiana Industries Pvt. Ltd., Shri Tejendra Singh, (Director) Sub Lessee of M.P. State Mining Corporation Limited, G-1, M-3, Sapna Chambers, 12/1, South Tukoganj, Indore (MP) - 452001 by SEIAA vide letter No. 1402/SEIAA/16 dated 10.05.2016 is hereby transferred to Shri K.P. Singh Bhadoriya, Contractor, E-46 A, Balwant Nagar, Thatipura, Gwalior (MP) for Sand Quarry (Opencast Manual Method) in an area of 6.00 ha. for production capacity of 1,20,000 cum/year at Khasra No.- 546, Village-Kamkomohaniya, Tehsil-Dindori, District-Dindori (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
