Chhatarpur (MP) by M/S Anandeshwar Agro Foods Private Limited, Shri. Sunil Gupta (Director) , MTC B-8, B-9 Panki Industrial Area Site No. 03 Kanpur (U.P) Uttar Pradesh - 208022.

The case was discussed in 602nd SEIAA meeting dtd. 02.03.2020 and it was recorded that.....

- (1) It was noted that the PP had applied in Form-I for Prior Environmental Clearance of 12.60 ha. but 3.70 ha. (As per SEAC recommendation) for production capacity of 378000 cum / year but 1,10,000 cum / year (As per SEAC recommendation) at Khasra no.- 405 at Village- Lagarha , Tehsil - Chandla, Dist. Chhatarpur (MP) by Sarpanch, Gram Panchyat Hatonha, Pahara B.O. Post Office, Tehsil - Chandla, Dist. Chhatarpur, MP -471525.
- (2) The Prior Environmental Clearance letter was issued SEIAA vide L.No. 199/SEIAA/18 dtd.04.05.2018 in the name of " Sarpanch, Gram Panchyat Hatonha, Pahara B.O. Post Office, Tehsil - Chandla, Dist. Chhatarpur, MP -471525.
- (3) It is noted that PP has requested vide no nil dtd.nil received in SEIAA office 28.02.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely " M/S Anandeshwar Agro Foods Private Limited, Shri. Sunil Gupta (Director) , MTC B-8, B-9 Panki Industrial Area Site No. 03 Kanpur (U.P) Uttar Pradesh - 208022." in place of "Sarpanch, Gram Panchyat Hatonha, Pahara B.O. Post Office, Tehsil - Chandla, Dist. Chhatarpur, MP -471525".
- (4) It is noted that in support of his request the PP has submitted the following documents

 - ii. Notarised affidavit of CEO - Shri Sikandar Khan, Janpad Panchyat Laudi, District Chhatarpur MP." mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued
 - iii. Notarised affidavit of Sarpanch, Gram Panchyat Hatonha, Pahara B.O. Post Office, Tehsil - Chandla, Dist. Chhatarpur, MP -471525". mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.



(5) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued SEIAA on 04.05.2018 in the name of "Sarpanch, Gram Panchyat Hatonha, Pahara B.O. Post Office, Tehsil - Chandla, Dist. Chhatarpur." is hereby transferred to M/S Anandeshwar Agro Foods Private Limited, Shri. Sunil Gupta (Director) , MTC B-8, B-9 Panki Industrial Area Site No. 03 Kanpur (U.P) Uttar Pradesh - 208022-". for Sand Quarry (Open cast manual method) in an area of 3.70 ha mineable area (As per SEAC recommendation) for production capacity of 1,10,000 (As per SEAC recommendation) cum per annum at Khasra no. 405 at Village- Lagarha , Tehsil - Chandla, Dist. Chhatarpur." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly


