The case was discussed in 609th SEIAA meeting dtd 06.05.2020 and it has been recorded that

- (1) " It was noted that the PP had applied in Form-I for Prior Environmental Clearance of 4.80 ha. for production capacity of 86,400 cum per annum at Khasra No. 396 at Village - Bharuhi, Tehsil - Bhari, Dist. Sidhi (MP) by **Sarpanch Gram Panchyat** Bharuhi, Tehsil - Bahri, Dist. Sidhi, MP.
- (2) The Prior Environmental Clearance letter was issued SEIAA vide L.No. 814/SEIAA/19 dtd. 23.05.2019 in the name of " **Sarpanch Gram Panchyat** Bharuhi, Tehsil - Bahri, Dist. Sidhi MP.
- (3) It is noted that PP has requested vide no Nil dtd. 05.05.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely " **M/s Sainik Industries Pvt.Ltd., Authorized person Shri Litesh Jha, 201-202, Vikas Plaza Building No. 2, Local Shopping Center Kalkaji New Delhi-110019.**" in place of **Sarpanch Gram Panchyat** Bharuhi, Tehsil - Bahri, Dist. Sidhi, MP. "
- (4) It is noted that in support of his request the PP has submitted the following documents

Notarised affidavit of "**M/s Sainik Industries Pvt.Ltd., Authorized person Shri Litesh Jha, 201-202, Vikas Plaza Building No. 2, Local Shopping Center Kalkaji New Delhi-110019**" mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - iii. Copy of Prior EC issued by SEIAA vide letter No. 814/SEIAA/19 dtd. 23.05.2019.
 - iv. Copy of Environmental Management Plan of **M/s Sainik Industries Pvt.Ltd., Authorized person Shri Litesh Jha, 201-202, Vikas Plaza Building No. 2, Local Shopping Center Kalkaji New Delhi-110019.**
 - v. Approved Mining Plan has been transferred by Collector, Sidhi vide L.No. 231/खनिज/2020 dated 07.03.2020 of **M/s Sainik Industries Pvt.Ltd., Authorized person Shri Litesh Jha, 201-202, Vikas Plaza Building No. 2, Local Shopping Center Kalkaji New Delhi-110019.**
 - vi. Copy of Approved Replenishment Plan of **M/s Sainik Industries Pvt.Ltd., Authorized person Shri Litesh Jha, 201-202, Vikas Plaza Building No. 2, Local Shopping Center Kalkaji New Delhi-110019.**

vii. Lease transfer order issued by Mineral Resource Department order to **M/s Sainik Industries Pvt.Ltd.**, Authorized person **Shri Litesh Jha**, 201-202, Vikas Plaza Building No. 2, Local Shopping Center Kalkaji New Delhi-110019 vide letter No. 1668/132/2020/12/1 dated 16.03.2020.


(5) It is noted that in EIA Notification 2006 as per **Para-11 Transferability of Environmental Clearance (EC)** there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.


In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued SEIAA on 22.05.2019 in the name of "**Sarpanch Gram Panchyat Bharuhi, Tehsil - Bahri, Dist. Sidhi, MP.**" is hereby transferred to **M/s Sainik Industries Pvt.Ltd.**, Authorized person **Shri Litesh Jha**, 201-202, Vikas Plaza Building No. 2, Local Shopping Center Kalkaji New Delhi-110019. **Sand mine** (opencast manual method) in an area of 4.80 ha. for production capacity of 86,400 cum per annum at Khasra No. 396 at Village - Bharuhi, Tehsil - Bhari, Dist. Sidhi (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. **All concerned be informed accordingly."**

In view of above, prior EC issued to **Sarpanch Gram Panchyat Bharuhi, Tehsil - Bahri, District-Sidhi** by DEIAA vide letter No. 756/SEIAA/19 dtd.22.5.2019 is hereby transferred to **M/s Sainik Industries Pvt.Ltd.**, Authorized person **Shri Litesh Jha**, 201-202, Vikas Plaza Building No. 2, Local Shopping Center Kalkaji New Delhi-110019 for Sand mine (opencast manual method) in an area of 4.80 ha. for production capacity of 86,400 cum per annum at Khasra No. 396 at Village - Bharuhi, Tehsil - Bhari, Dist. Sidhi (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
