Banthiya, Rajendra Marg, Town & Teh. - Mahidpur, Ujjain (MP)-456443. - **Regarding transfer of EC in the name of Shri Kishore Verma , S/o Shri Bherulal Verma, R/o 78/1, Jail Road, Mahidpur, District Ujjain, (MP)**

The case was discussed in 640th SEIAA meeting dtd 01.10.2020 and it has been recorded that

- (1) PP had applied in Form-I in SEIAA for Prior Environmental Clearance for Basalt Stone Quarry in an area of 1.00 ha. (1,000 cum/year) at khasra no 404/1 at Village-Sekakhedi, Tehsil-Mahidpur, Dist-Ujjain (MP) by Shri Hitesh Banthiya S/o Shri K.M. Banthiya, Rajendra Marg, Town & Teh. - Mahidpur, Ujjain (MP).
- (2) The Prior Environmental Clearance letter was issued vide L.No. 3845/ SEIAA/15 dated 17.07.2015 in the name of " Shri Hitesh Banthiya S/o Shri K.M. Banthiya, Rajendra Marg, Town & Teh. - Mahidpur, Ujjain (MP)-456443".
- (3) PP has requested vide no Nil dtd. 07.07.2020 received in SEIAA Office dtd. 07.07.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely " Shri Kishore Verma , S/o Shri Bherulal Verma, R/o 78/1, Jail Road, Mahidpur, District Ujjain, (MP)" in place of " Shri Hitesh Banthiya S/o Shri K.M. Banthiya, Rajendra Marg, Town & Teh. - Mahidpur, Ujjain (MP)-456443.
- (4) PP has submitted the following documents in support of his request :
 - i. No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of Shri Kishore Verma , S/o Shri Bherulal Verma, R/o 78/1, Jail Road, Mahidpur, District Ujjain, (MP).
 - ii. Notarised affidavit of Shri Hitesh Banthiya S/o Shri K.M. Banthiya, Rajendra Marg, Town & Teh. - Mahidpur, Ujjain (MP)-456443 mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - iii. Copy of Prior EC issued by SEIAA, vide L.No. 3845/ SEIAA/15 dated 17.07.2015
 - iv. Copy of Lease order issued by Office of Collector (Mining Division) to Shri Kishore Verma , S/o Shri Bherulal Verma, R/o 78/1, Jail Road, Mahidpur, District Ujjain, (MP) vide endt letter No. 341 dated 20.02.2017 .
- (5) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the

Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued in SEIAA, in the name of " **Shri Hitesh Banthiya S/o Shri K.M. Banthiya, Rajendra Marg, Town & Teh. - Mahidpur, Ujjain (MP)-456443** " is hereby transferred to " **Shri Kishore Verma, S/o Shri Bherulal Verma, R/o 78/1, Jail Road, Mahidpur, District Ujjain, (MP),**". For Basalt Stone Quarry in an area of 1.00 ha. (1,000 cum/year) at khasra no 404/1 at Village-Sekakhedi, Tehsil-Mahidpur, Dist-Ujjain (MP) on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly"

In view of above, prior EC issued to **Shri Hitesh Banthiya S/o Shri K.M. Banthiya, Rajendra Marg, Town & Teh. - Mahidpur, Ujjain (MP)-456443** by SEIAA vide letter No. 3845/ SEIAA/15 dated 17.07.2015 is hereby transferred to **Shri Kishore Verma, S/o Shri Bherulal Verma, R/o 78/1, Jail Road, Mahidpur, District Ujjain, (MP)** for Basalt Stone Quarry in an area of 1.00 ha. (1,000 cum/year) at khasra no 404/1 at Village-Sekakhedi, Tehsil-Mahidpur, Dist-Ujjain (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
