- (1) "It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for Basalt Stone Quarry in an area of 8.930 ha. for production capacity of 86,700 cum/year at Khasra No. 229 to 248 at Village-Khamhariya, Tehsil-Jabalpur, District-Jabalpur (MP) by M/s Khairapati Mines & MInerals, Partner Shri Mamlesh Sharma R/o 14/473, Ghadi Chowck, Vijay Nagar, District Jabalpur (MP).
- (2) The Prior Environmental Clearance letter was issued by SEIAA vide L.No. 1230/SEIAA/19 dated 21.06.19 in the name of M/s Rao Construction, Prop. Shri Rao Hemraj SIngh S/o Shri Rao Devi Singh Village Kanjai, Tehsil Gotegaon, District Narsinghpur (MP).

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by SEIAA on 21.06.19 in the name of " M/s Rao Construction, Prop. Shri Rao Hemraj SIngh S/o Shri Rao Devi Singh Village -Kanjai, Tehsil - Gotegaon, District Narsinghpur (MP) is hereby transferred to M/s Khairapati Mines & MInerals, Partner Shri Mamlesh Sharma R/o 14/473, Ghadi Chowck, Vijay Nagar, District Jabalpur (MP) for Basalt Stone Quarry (Opencast semi mechanized method) in an area of 8.930 ha. for production capacity of 86,700 cum/year at Khasra No. 229 to 248 at Village-Khamhariya, Tehsil-Jabalpur, District-Jabalpur (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
