- (1). Prior Environmental clearance has been issued to SVC Resources Ltd. Nabbharat, Udhoyg Bhawan, 2nd Floor, Ring Road No. 1,Telibhandha, P. O. Ravigram, Distt. Raipur, Chhatisgarh vide letter no. 429/EPCO/SEIAAV11 dated 27.08.11 for Iron ore beneficiation plant for production capacity of 90000 MTPA at vill-Dhamki, Teh- Sihora, Distt. Jabalpur-M.P
- (2). Now Vide online proposal no. SIA/MP/IND/218852/2021 received in SEIAA office on 04.10.21 PP has requested to transfer the Environment Clearance from SVC Resources Ltd.to M/s Sagar Stone Industies.
- (3). A lease deed executed on 30:04,2013 between M/s SVC Resources Ltd. through Director Shri Akashat Gupta and M/s Sagar Stone industries through Partner Shri Nitin Sharma.
- (4). M/s Sagar Stone Industries registered the unit under District Trade & industries Centre, Jabalpur on 20.02.2013 to set up unit of Iron Ore Benefication Manufacturing services.
- (5). The land of plant was also purchased by Sagar Stone Industries from SVC Resources Ltd. on 28.02.2018, as land was on lease prior to the 28.02.2018.
- (6). For transfer of Environmental clearance PP has submitted as follows:
  - An affidavit from Authorized Signatory, Sagar Stone Industries Private Limited regarding comply all the conditions stipulated in the prior Environmental Clearance letter no. 429/EPCO/SEIAA/11 dated 27.08.11.
  - NoC from Existing Environmental Clearance holder (M/s SVC Resources).
  - Lease deed between SVC Resources & Sagar Stone Industries
  - Land registry SVC resources to Sagar Stone Industries

The case was discussed in depth and it is noted that as per Para 11 of EIA Notification, 2006 "A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period....."

The matter of change in the name/transfer of environmental clearance was considered in the 701<sup>st</sup> SEIAA meeting dtd. 12.01.22,after due consideration of the documents submitted by PP, SEIAA authority decided to accord approval for change in the name/transfer of EC as mentioned above as per provision of para 11 of Environment Impact Assessment Notification,2006.

As per decision in State Level Environment Impact Assessment Authority (SEIAA), in its 701<sup>st</sup> meeting held on 12.01.22 the prior Environmental Clearance issued to M/s SVC Resources Ltd (Transferor) for Iron ore beneficiation plant for proudction capacity of 90000 MTPA at village -Dhamki, Teh- Sihora, Distt. Jabalpur-M.P vide letter no. 429/EPCO/SEIAA/11 dated 27.08.11 is transferred to Sagar Stone Industries (Transferee) for the above project with the same terms and conditions

under which the prior environmental clearance dated 27.08.11 was initially granted for the same validity period. In future all compliances and correspondence shall be strictly done by Sagar Stone Industries.
