Sub:- Case No. 5497/2021, Prior Environment Clearance for **River Sand Deposit Quarry** in an area of 7.00 ha. for production capacity of 5000 cum per annum at Khasra no. 484 Village- Chandangaon, Tehsil - Chhindwara, Dist. - Chhindwara (MP) by Shri Shishir Khandar, Samsheesh Bhawan, 18 Malik complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur – 440025 (Maharashtra).

The case was discussed in 675th SEIAA meeting dtd 08.04.2021 and it has been recorded that

- (1) " It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for Stone Quarry in an area of 1.00 ha. for production capacity of 14221 cum per annum at Khasra no. 74 Village - Dhadhra, Tehsil - Jabalpur, Dist. Jabalpur (MP) by Shri Shishir Khandar, Samsheesh Bhawan, 18 Malik complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur – 440025 (Maharashtra).
- (2) The Prior Environmental Clearance letter was issued by SEIAA vide L.No. 5659/SEIAA/17 dated 23.03.2017 in the name of M/s Pawar Constructions, Ward No. 34, Mata Mandir Colony, Chandangaon, Tehsil & Dist.- Chhindwara (MP).
- (3) It is noted that in support of his request the PP has submitted the following documents.
 - i. No Objection Certificate in the form of Notarised Affidavit submitted by **District Mining Officer, Chhindwara - MP (on behalf of previous project proponent)** for transfer of prior EC in the name of **Shri Shishir Khandar, Samsheesh Bhawan, 18 Malik complex , Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur (Maharashtra)**.
 - ii. Notarised affidavit of **Shri Shishir Khandar, Samsheesh Bhawan, 18 Malik complex , Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur (Maharashtra)** mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - iii. Copy of Prior EC issued by SEIAA vide letter no. vide L.No. 5659/SEIAA/17 dated 23.03.2017.
 - iv. Copy of Environmental Management Plan of **Shri Shishir Khandar, Samsheesh Bhawan, 18 Malik complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur (Maharashtra)**.
 - v. Copy of Approved Mining Plan transferred by Collector, District –Chhindwara (vide Letter No. 4558 /sand/neelaam Khadan/ 2021 dated 01.03.2021) and approved replishment plan to **Shri Shishir Khandar, Samsheesh Bhawan, 18 Malik complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur (Maharashtra)**.
 - vi. Lease transfer order issued by Office of Mineral Resource Department, Govt. of Madhay Pradesh to **Shri Shishir Khandar, Samsheesh Bhawan, 18 Malik complex , Tenament Hotel,**

- (4) It is noted that in EIA Notification 2006 as per **Para-11 Transferability of Environmental Clearance (EC)** there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by DEIAA on 23.03.2017 in the name of "M/s Pawar Constructions, Ward No. 34, Mata Mandir Colony, Chandangaon, Tehsil & Dist.- Chhindwara (MP) - 480001 is hereby transferred to Shri Shishir Khandar, Samsheesh Bhawan, 18 Malik complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra) for River Sand Deposit Quarry in an area of 7.00 ha. for production capacity of 5000 cum per annum at Khasra no. 484 Village- Chandangaon, Tehsil - Chhindwara, Dist. - Chhindwara (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. **All concerned be informed accordingly.**"

In view of above, prior EC issued to M/s Pawar Constructions, Ward No. 34, Mata Mandir Colony, Chandangaon, Tehsil & Dist.- Chhindwara (MP) - 480001 by SEIAA vide letter No. 5659/SEIAA/17 dated 23.03.2017 is hereby transferred to Shri Shishir Khandar, Samsheesh Bhawan, 18 Malik complex, Tenament Hotel, Airport Center Point, Somalwada, Wardha Road, Nagpur - 440025 (Maharashtra) for River Sand Deposit Quarry in an area of 7.00 ha. for production capacity of 5000 cum per annum at Khasra no. 484 Village- Chandangaon, Tehsil - Chhindwara, Dist. - Chhindwara (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
