The case was discussed in 644<sup>th</sup> SEIAA meeting dtd. 07.10.2020 and it was recorded that.....

1. It was noted that the PP had applied in Form-IM for Prior Environmental Clearance of 4.0 ha. (25057 cum per annum) (Khasra No. 847), Village - Kalma, Tehsil - Tonkkurd, Dist. Dewas (MP) by M/s Thekadar, Shri Laxman Singh Rajput, R/o – 182, Push Kunj Colony, Etava Dewas, Tehsil & District Dewas, MP – 455001.
2. The Prior Environmental Clearance letter was issued DEIAA (Case no.76/2016) vide L.No. 73/DEIAA/16 dtd.05.07.2016 in the name of " M/s Thekadar, Shri Laxman Singh Rajput, R/o – 182, Push Kunj Colony, Etava Dewas, Tehsil & District Dewas, MP – 455001."
3. It is noted that PP has requested vide no nil dtd. nil received in SEIAA office 03.10.2020 to make amendment in the Prior EC letter by changing the name of PP of the mining project namely " M/s Udai Mines, Partner – Shri Udai Mishra, R/o Scheme no. 94, Bharfani Dham Chouraha, Ring road , Dist. Indore, MP – 455001" in place of "M/s Thekadar, Shri Laxman Singh Rajput, R/o – 182, Push Kunj Colony, Etava Dewas, Tehsil & District Dewas, MP – 455001..".
4. It is noted that in support of his request the PP has submitted the following documents
  - i. No objection letter of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of M/s Udai Mines, Partner – Shri Udai Mishra, R/o Scheme no. 94, Bharfani Dham Chouraha, Ring road , Dist. Indore, MP – 455001.
  - ii. Notarised affidavit of M/s Thekadar, Shri Laxman Singh Rajput, R/o – 182, Push Kunj Colony, Etava Dewas, Tehsil & District Dewas, MP – 455001, mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued. .
  - iii. Copy of Prior EC issued by DEIAA (Case no.76/2016) vide L.No. 73/DEIAA/16 dtd.05.07.2016.
  - iv. Copy of Approved Mining Plan with Environmental Management Plan of M/s Udai Mines, Partner – Shri Udai Mishra, R/o Scheme no. 94, Bharfani Dham Chouraha, Ring road , Dist. Indore, MP – 455001
  - v. Lease transfer order issued by Collector Office (Mining Division) order to of M/s Udai Mines, Partner – Shri Udai Mishra, R/o Scheme no. 94, Bharfani Dham Chouraha, Ring road , Dist. Indore, MP – 455001, vide letter No. 147/khanij/2020/dated 31.01.2017.

5. It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

**Para-11 :-** A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued SEIAA on 25.07.2016 in the name of " M/s Thekadar, Shri Laxman Singh Rajput, R/o – 182, Push Kunj Colony, Etava Dewas, Tehsil & District Dewas, MP " is hereby transferred to "M/s Udai Mines, Partner – Shri Udai Mishra, R/o Scheme no. 94, Bharfani Dham Chouraha, Ring road , Dist. Indore, MP – 455001-". for Stone Quarry (Opencast Semi Mechanized Method) in an area of 4.0 ha. (25057 cum per annum) (Khasra No. 847), Village - Kalma, Tehsil - Tonkkurd, Dist. Dewas (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.

Hence, the Prior Environmental Clearance issued to " M/s Thekadar, Shri Laxman Singh Rajput, R/o – 182, Push Kunj Colony, Etava Dewas, Tehsil & District Dewas, MP vide dtd.25.07.2016 for Stone Quarry (Opencast Semi Mechanized Method) in an area of 4.0 ha. (25057 cum per annum) (Khasra No. 847), Village - Kalma, Tehsil - Tonkkurd, Dist. Dewas (MP) is hereby transferred to M/s Udai Mines, Partner – Shri Udai Mishra, R/o Scheme no. 94, Bharfani Dham Chouraha, Ring road , Dist. Indore, MP – 455001 . on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
