The case was discussed in 669th SEIAA meeting dtd. 26.03.2021 and it was recorded that.....

- (1) It was noted that the PP had applied in Form-7 for Prior Environmental Clearance of 4.0 ha. for production capacity of 161984 cum per annum at Khasra No. 1214 at Village - Didwara, Tehsil - Lavkushnagar, Dist. Chhatarpur (MP) by M/s Balaji Stone Mill R/o Gandhi Nagar Mahoba (UP).
- (2) The Prior Environmental Clearance letter was issued DEIAA vide L.No. 538/DEIAA/2017 dtd 4.3.2017 in the name of M/s Balaji Stone Mill R/o Gandhi Nagar Mahoba (UP).
- (3) It is noted that in support of his request the PP has submitted the following documents:

No objection letter (in form of affidavit) of M/s Balaji Stone Mill R/o Gandhi Nagar Mahoba (UP)..on behalf of previous Project Proponent (to whom prior EC was granted) for transfer of prior EC in the name of M/s Om Granite, Shri Sanjay Joshi, Partner, R/o Village - Didwara, Tehsil - Lavkush Nagar, Dist. Chhatarpur, MP - 471510,
 - ii. Notarised affidavit of M/s Om Granite, Shri Sanjay Joshi, Partner, R/o Village - Didwara, Tehsil - Lavkush Nagar, Dist. Chhatarpur, MP - 471510, mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - iii. Copy of Prior EC issued by DEIAA vide letter No. 538/DEIAA/2017 dtd 4.3.2017. to M/s Balaji Stone Mill R/o Gandhi Nagar Mahoba (UP)

vi. Lease transfer order issued by **Collector (Mining Division)** to M/s Om Granite, Shri Sanjay Joshi, Partner, R/o Village - Didwara, Tehsil - Lavkush Nagar, Dist. Chhatarpur, MP - 471510 MP vide letter No. 212/Khanij/17 dated **28.8.2017**.

(4) It is noted that in EIA Notification 2006 as per **Para-11 Transferability of Environmental Clearance (EC)** there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.


In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued on 4.3.2017 in the name of " M/s Balaji Stone Mill R/o Gandhi Nagar Mahoba (UP). is hereby transferred to M/s Om Granite, Shri Sanjay Joshi, Partner, R/o Village - Didwara, Tehsil - Lavkush Nagar, Dist. Chhatarpur, MP - 471510- for Stone Quarry in an area of 4.0 ha. for production capacity of 161984 cum per annum at Khasra No. 1214 at Village - Didwara, Tehsil - Lavkushnagar, Dist. Chhatarpur MP for production capacity of 161984 cum per annum at Khasra No. 1214 at Village - Didwara, Tehsil - Lavkushnagar, Dist. Chhatarpur (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.
