Sub:- Case No. 2131 /2014- Prior Environmental Clearance for Sand Quarry in an area of 4.250 ha, for production capacity 25000 cum/year at Khasra No. 213/1/1, 224/6/5 at Village Perkhad, Tehsil Manavar, District Dhar, MP by M/s DIPL C/o Shri Sukhdev Singh & Tejinder Singh, G-1, Sapna Chamber, South Tukoganj, Indore (MP)-452001.

This has reference to your letter received in SEIAA office on 24.11.2014 and subsequent letters seeking Prior Environmental Clearance for the above project under the EIA Notification, 2006. The proposal has been appraised as per prescribed procedure in the light of provisions under the EIA Notification, 2006 on the basis of the mandatory documents enclosed with the application viz., the Form – I, Appendix-1 Mining Plan & EMP, the additional clarifications furnished in response to the observations of the State Expert Appraisal Committee (SEAC) and State Environment Impact Assessment Authority (SEIAA) constituted by the competent Authority.

- II. There is no National Park/Sanctuary and interstate boundary within 10 Km radius. There is no human settlement within 500 m. from mining site. The nearest forest boundary is 50 km. from mining site.
 - The Sand Quarry project is for production capacity of 25,000 cum per year. The proposed mining is for Two years. The mining will be carried out by Manual method.
- III. The project has been considered in accordance with the provisions of the EIA notification issued by the Ministry of Environment & Forests vide S.O. 1533 (E), dated 14th September 2006.
- IV. Based on the information submitted, as at Para (II) above and others the State Level Environment Impact Assessment Authority (SEIAA) considered the case in its 174th meeting dtd. 12.01.2015 and decided to accept the recommendations of 159th SEAC meeting dtd. 01.12.2014.

Hence, Prior Environmental Clearance is granted for Sand Quarry (Manual method) in an area of 4.250 ha. for production capacity 25,000 cum/year at Khasra No. 213/1/1, 224/6/5 at Village Perkhad, Tehsil Manavar, District Dhar, MP for the period of 02 years by M/s DIPL C/o Shri Sukhdev Singh & Tejinder

Singh, G-1, Sapna Chamber, South Tukoganj, Indore (MP)-452001, subject to the compliance of the Standard Conditions enclosed at. **Annex-I** and the following additional specific conditions as recommended by SEIAA & SEAC.

- 1. PP shall not start mining activity before execution of lease agreement.
- The average depth of the pit shall not exceed 3.0m or water level, whichever is less at the end of lease period.
- The amount towards reclamation of the land in MLA shall be carried out through the
 mining department the appropriate amount as estimated for the activity by mining
 department has to be deposited with the Collector to take up the activity after the
 mine is exhausted.
- PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
- PP shall use the rejects and soil for plantation on theses eroded banks to prevent damages of the banks.
- Mining shall be carried only between 1st November to 31st May i.e. during nonmonsoon period.
- 7. Transportation of sand shall not be carried out through forest area.
- The mining activity shall be done manually.
- 9. Heavy vehicles shall not be allowed on the banks for loading of sand.
- 10. The sand shall be transported by small trolleys up to the main transport vehicle.
- Transport vehicles will be covered with taurpoline to minimize dust/sand particle emissions.
- 12. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone of 1 Km on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
- No in stream mining shall be allowed.
- 14. The mining shall be carried out strictly as per the approved mining plan and ensure thatthe annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
- Established water conveyance channels should not be relocated, straightened, or modified.
- If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
- After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
- PP shall take Socio-economic activities in the region through the 'Gram Panchayat'.

Annex-I

Standard Conditions related to Activity 1 (a) - < 5 ha Mining Lease Area for Sand Mining

- Mining will be carried out as per the approved EMS. In case of any violation of EMS the Environmental Clearance given by SEIAA will stand cancelled.
- It shall be ensured that excavation of minor mineral does not disturb or change the 2 underlying soil characteristics of the river bed /basin, where mining is carried out.
- It shall be ensured that mining does not in any way disturb the turbidity, velocity 3 and flow pattern of the river water.
- It shall be ensured that there is no fauna dependant on the river bed or areas close to mining for its nesting.
- Precise mining area will be jointly demarcated at site by officials of Mining/Revenue department prior to mining operations for proposal under consideration.
- Parking of vehicles should not be made on public places.
- Special Measures shall be adopted to prevent the nearby settlements from the 7 impacts of mining activities. Maintenance of roads through which transportation of minor minerals is to be undertaken, shall be carried-out regularly.
- Measures for prevention and control of soil erosion and management of silt shall be undertaken.
- The project proponent will ensure necessary protection measures around the mine pit, waste dumps.
- 10 Plantation programme shall be carried out as per EMS. Self sustenance of the vegetation should be ensured. No tree-felling shall be done in the leased area, except only with the permission from competent authority.
- 11 The vehicles transporting minerals shall be covered with a tarpaulin or other suitable enclosures so that no dust particles / fine matters escape during the course of transportation
- 12 Project Proponent shall ensure appropriate arrangement for shelter and drinking water for the mine workers.
- 13 Persons working in dusty areas shall be provided with protective respiratory devices and they shall also be imparted adequate training and information on safety and health aspects.

14 Dispensary facilities for first-aid shall be provided at site.
