**Sub:- Case No. 967/2012-** Prior Environmental Clearance for sand quarry (Manual) in an area of 0.90 ha for production capacity 36,000 cum / year at Khasra No. 262 Village Delwani, Tehsil Sondwa, District Alirajpur, MP by Shri Antar Singh S/o Shri Shankar Singh, Village Bhordiya, Tehsil Alirajpur, District Alirajpur, MP-457887.

This has reference to your letter no. A-124/2012 dtd 26.09.2012 received in SEIAA office on 01.10.2012 and subsequent letters seeking Prior Environmental Clearance for the above project under the EIA Notification, 2006. The proposal has been appraised as per prescribed procedure in the light of provisions under the EIA Notification, 2006 on the basis of the mandatory documents enclosed with the application viz., the Form – I, Appendix-1 & II, the additional clarifications furnished in response to the observations of the State Expert Appraisal Committee (SEAC) and State Environment Impact Assessment Authority (SEIAA) constituted by the competent Authority.

II. It has been noted that the proposal is for **Sand Quarry** in an area of 0.90 ha. The mining lease area is located in **Khasra No. 262** at Village Delwani, Tehsil Sondwa, District Alirajpur, MP. There is no National Park/Sanctuary and interstate boundary within 10 Km radius. There is no human settlement/water body within 500 m. from mining site. The nearest forest boundary is in between 250-300 m. from mining site.

The Sand Quarry project is for production capacity of 36,000 cum per year. The proposed mining lease period is for **two years**. The mining will be carried out by maunal method.

III. The project has been considered in accordance with the provisions of the EIA notification issued by the Ministry of Environment & Forests vide S.O. 1533 (E), dated 14<sup>th</sup> September 2006.

IV. Based on the information submitted, as at Para (II) above the State Level Environment Impact Assessment Authority (SEIAA) considered the case in its

128<sup>th</sup> meeting dtd. 03.05.2013 and decided to accept the recommendations of 119<sup>th</sup> SEAC meeting dtd. 02.02.2013.

Hence, Prior Environmental Clearance is accorded for **Sand Quarry** in an area of 0.90 ha. for production capacity of 36,000 cum/year at Khasra No. 262 at Village Delwani, Tehsil Sondwa, District Alirajpur, MP for lease period of **Two years** by Shri Antar Singh S/o Shri Shankar Singh, Village Bhardiya, Tehsil Alirajpur, District Alirajpur, MP-457887 under the provisions of EIA notification dtd. 14<sup>th</sup> September, 2006, subject to the compliance of the Standard Conditions enclosed at **Annex-I** and the following additional specific conditions as recommended by SEIAA & SEAC.

1. If the land belongs to the tribal person the Collector shall ensure that the tribal person gets compensation as per rule 72 of the Mineral Concession Rule 1960 and his interests are safeguarded as per State Policy.
2. The final EMS as proposed by the PP and the budgetary provisions for its implementation shall be approved by the Collector and shall be submitted to SEIAA.
3. PP shall be responsible for any discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
4. Transportation of material shall be done in covered vehicles.
5. Curtaining of site shall be done using appropriate media.
6. Sieve or any other sizing device shall not be allowed in the mining lease area.
7. The proposed plantation should be carried out along with the mining and PP should take care that these plants attain full growth.
8. Transportation shall not be carried out through forest area.
9. PP shall take CSR activities in the region through the 'Gram Panchayat'.
10. The amount towards EMP shall be deposited with the Collector for further execution of the activities under EMP.
11. **The sand mining should be carried out at the distance of 15 m. from the stream bed.**
12. Before granting the lease or permit to the PP the Collector will ensure that, there is no other prior existing mining lease or permit in operation at or within the distance of 250 m. from the this case mining area which makes the total mining lease area more than 5.0 ha. He shall intimate the position within one month to the SEIAA.
13. In case there is no other mining lease or permit in operation within 250 m. distance the Collector will also ensure that the permission for any new mine will not be granted without Prior EC from competent authority.
14. The collector will get a detailed EMS from PP and approve it before granting mining lease or permit. Following points should be incorporated in the EMS :-
  - Precaution during dumping and stabilization of the top soil to be excavated and its utilization for rehabilitation of the land after quarrying.
  - Scheme of removal, storage and utilization of overburden.
  - Scheme of plantation of trees.

- Measure for prevention air and water pollution.
  - Specific measures for addressing socio-economic concerns of local inhabitants like health, water, employment etc.
  - Other measures to be taken for minimizing the adverse effect of quarrying operation on the environment.
15. The Collector or an officer authorized by him will ensure the implementation of the EMS accordingly.
16. The PP will submit the approved copy of the EMS to the SEIAA office within 15 days of its approval from the Collector.



## Annex-I

### Standard Conditions related to Activity 1 (a) - < 5 ha Mining Lease Area for Sand Mining

- 1 Mining will be carried out as per the approved EMS. In case of any violation of EMS the Environmental Clearance given by SEIAA will stand cancelled.
- 2 It shall be ensured that excavation of minor mineral does not disturb or change the underlying soil characteristics of the river bed /basin, where mining is carried out.
- 3 It shall be ensured that mining does not in any way disturb the turbidity, velocity and flow pattern of the river water.
- 4 It shall be ensured that there is no fauna dependant on the river bed or areas close to mining for its nesting.
- 5 Precise mining area will be jointly demarcated at site by officials of Mining/Revenue department prior to mining operations for proposal under consideration.
- 6 Parking of vehicles should not be made on public places.
- 7 Special Measures shall be adopted to prevent the nearby settlements from the impacts of mining activities. Maintenance of roads through which transportation of minor minerals is to be undertaken, shall be carried-out regularly.
- 8 Measures for prevention and control of soil erosion and management of silt shall be undertaken.
- 9 The project proponent will ensure necessary protection measures around the mine pit, waste dumps.
- 10 Plantation programme shall be carried out as per EMS. Self sustenance of the vegetation should be ensured. No tree-felling shall be done in the leased area, except only with the permission from competent authority.
- 11 The vehicles transporting minerals shall be covered with a tarpaulin or other suitable enclosures so that no dust particles / fine matters escape during the course of transportation.
- 12 Project Proponent shall ensure appropriate arrangement for shelter and drinking water for the mine workers.
- 13 Persons working in dusty areas shall be provided with protective respiratory devices and they shall also be imparted adequate training and information on safety and health aspects.
- 14 Dispensary facilities for first-aid shall be provided at site.



- 15 A copy of the environmental clearance shall be submitted by the Project Proponent to the Heads of the Local Bodies, Panchayat and Municipal Bodies, as applicable, in addition to the relevant officers of the Government
- 16 The Ministry or any other competent authority may alter/modify the conditions or stipulate any further condition in the interest of environment protection.
- 17 Concealing factual data or submission of false/fabricated data and failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of Environment (Protection) Act, 1986.
- 18 Any appeal against this prior environmental clearance shall lie with the Green Tribunal, if necessary, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
