With reference to above, you are hereby informed that, in the EIA Notification, 2006 (as amended) under para no. 10 the following provision has been given:-  
*"It shall be mandatory for the project management to submit half-yearly compliance report in respect of the stipulated period environment clearance terms and condition in hard and soft copies to the regulatory authority concerned, on 1st June and 1st December of each calendar year"*

The SEIAA while according Environmental Clearance to your projects is also imposing the condition for submission of compliance report as per requirement of EIA Notification, 2006.

SEIAA issued environmental clearance for your project vide letter No: 1705/SEIAA/2018 dtd. 16/11/18 however, the six monthly compliance reports have not been submitted by you till now. As per MoEF & CC, GoI Notification dtd. 26.11.2018 soft copy of compliance report will now be uploaded by PP on Ministry's website instead of submitting hard and soft copy.

In light of above, you are requested to kindly submit all the backlog Compliance reports along with related annexure and photographs including CER/CSR activities on MoEF & CC, GoI website by informing to concerned regulatory authority i.e. SEIAA/ Regional Office, MoEF & CC, GoI, Bhopal positively up to 29.10.2021.

If you have submitted any compliance report in the Regional office of the MOEF on regular basis kindly submit the receipt for the same otherwise the case will be considered for revocation of EC as per MPSEIAA office memorandum 30.05.2019.
