Minutes of the 212" Meeting of SEIAA dated 24,06,2015

Jujharpura, Tehsil Bakswaha, District Chhatarpur (M.P.) for the lease period to Shri Rajat Choudhary, S/o Shri Bhagwandas Choudhary, Gaupura, Hridaypur, Damoh (M.P)-470661.

- 11. Case No. 2141/2014, Prior Environmental Clearance for Metal Stone Quarry in an area of 4.00 ha for Production Capacity of 53378 cum/ year at Khasra no. 119 at Village Lahera, Tehsil Chhatarpur, District Chhatarpur, M. P. by Shri Alok Saxena, Res - Jawahar Road, Naugaon, Distt. Chhatarpur (M.P) - 471201.
 - (1) After detailed discussions and perusal of the query response of 188th SEIAA meeting dated 18 03 2015 and recommendations of 170th SEAC meeting dtd. 28,01,2015, it was decided to grant Environmental Clearance with slight modifications of the conditions imposed by SEAC.
 - PP shall not start mining activity before execution of lease agreement.
 - The average depth of the pit shall not exceed 6.0m at the end of lease

Hence, Prior Environmental Clearance is granted for Metal Stone Quarry in an area of 4.00 ha for Production Capacity of 53378 cum/ year at Khasra no. 119 at Village Lahera, Tehsil Chhatarpur, District Chhatarpur (M.P) for the lease period to Shri Alok Saxena, Res - Jawahar Road, Naugaon, Distt. Chhatarpur

C. Policy Decision

MoEF & CC, GoI has endorsed a copy of the letter (vide no. J-11015/93/2014-IA.II (M) dtd 12.03.2015) addressed to M/s Billaua Stone Crusher Association in which they have categorically stated that the Association should apply to MP-SEIAA as Individual Lol/ lease holders. MP-SEIAA in response to the directive of MoEF & CC. Gol had sought (vide no. 1359/SEIAA/15 dtd 26.05.2015) clarification from them on the cluster situation arising of 102 ha of proposed mining area. However, in its reply MoEF & CC, Gol (vide no. -11015/93/2014-IA.II (M) dtd 18.06.2015) has reiterated that individual lease holders may apply to MP-SEIAA for obtaining prior EC. MP-SEIAA has therefore decided to entertain online applications to be submitted by the individual lease holders in case of Billaua
