"Case was presented in the 317th SEAC meeting dated 20/06/2018 and quarries were raised for which PP was asked to submit response. Letter was issued to PP for submission of desired information vides letter no. 221 dated 10/07/2018.

Since PP has not submitted the desired information and case is pending since June, 2018 thus case may be delisted as per MoEF&CC OM J- 11013/5/2009-IA-II (Part) dated 30/10/2012."

As per above recommendation of SEAC, it has been decided to delist the case on the condition that if PP intends to present the case in SEIAA, it will then be relisted for appraisal. Copy to PP and all concerned.

PP has submitted point-wise query reply and desired information vide letter dated 29.08.20 with request to relist the case as PP is now ready to present their case in SEAC. Considering the request of PP, it was decided to relist the case and send the technical file to SEAC for appraisal. Copy to PP and all concerned.

As per above decision, the case is hereby relisted and the above information submitted by PP along with technical file is being sent for appraisal.
