The case was discussed in 643rd SEIAA meeting dated 06.10.20 and it was recorded that


" The following cases were discussed in 464th SEAC meeting dated 03.10.2020 and it was recorded that.....

PP requested to relist the case vide letter dated 28.10.20. After discussion it was decided to relist the case and send the technical file to SEAC for appraisal.


