PP has submitted required documents vide letter dated. 21.09.2021 received in SEIAA Office and requested to relist the case by showing interest to present their case in SEAC. Considering the request of PP, it was decided to relist the case and technical file send to SEAC for appraisal."

In view of above decision, the case is hereby relisted. The technical file is being sent for appraisal and you are requested to take the considered view on it.


