Dear Sir,

With respect to the cited subject, we would like to state that our case no. 1687/2013 for prior Environmental Clearance (EC) was placed before the SEAC as per our application in the meeting held on dated 25.07.2013.

During the meeting we had submitted following facts before the committee.

- Company has applied for consent to establish under Air and Water Act vide our on-line application dated July, 2012 to M.P. Pollution Control Board.
- Technical presentation was made before MPPCB on 18.10.2012
- As per MOM of technical presentation company was asked to obtain prior EC as the propose built up area is more than 20,000 sq. mtr.
- Accordingly application for prior EC was file with SEIAA.
- Meanwhile company initiated construction activities, as the company official's were not aware of provision of EIA notification.
- Now we are aware that violation of EIA notification have been committed by us and after deliberation, SEAC has directed us to discuss the matter with MPPCB so that credible action as per MOEF OM No. J-11013/41/2006-IA.II(I) dated 12th Dec. 2012 may be initiated by the M.P. Pollution Control Board.
- We have requested the Member Secretary of M.P. Pollution Control Board, Bhopal to initiate the credible action so that our case can be considered for Environmental Clearance. Copy of letter is attached for your reference.
- We are also attaching affidavit (in original) on resolution passed in the Meeting of Management.

In light of above facts it is requested to consider our case for Environmental Clearance.



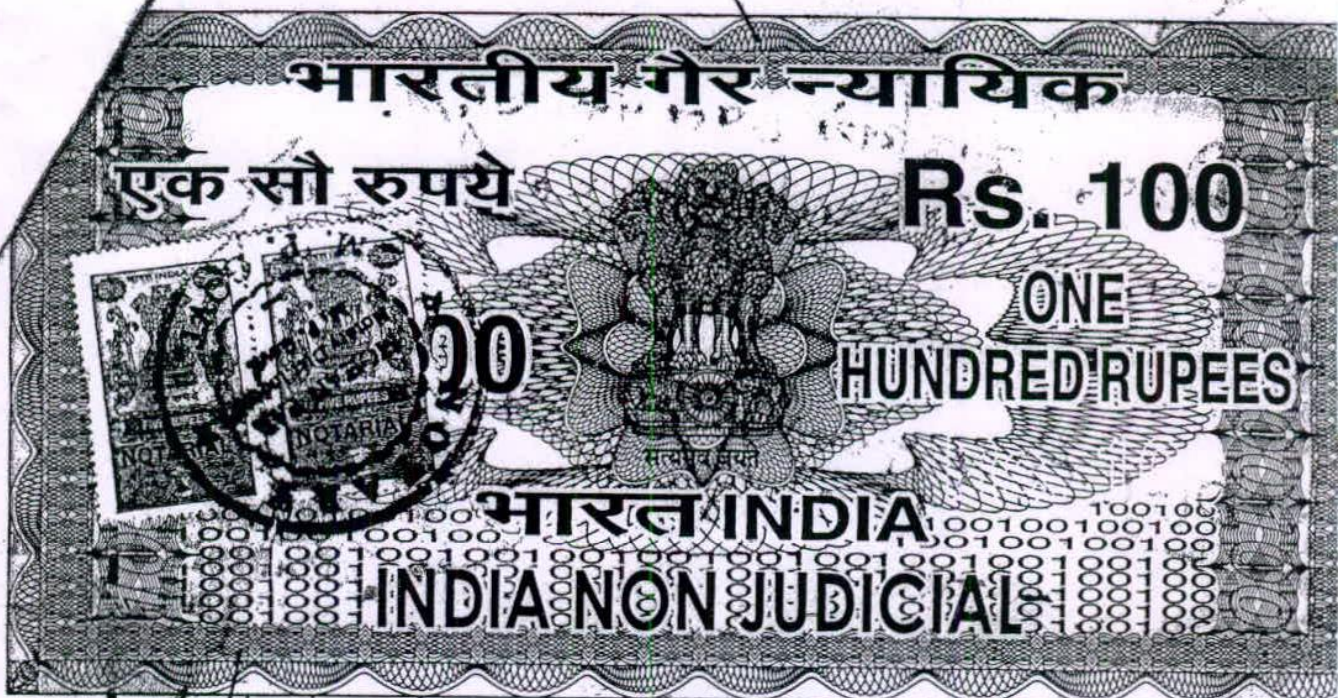

A meeting of the management of M/s. M/s KMM Real Estate & Construction Pvt. Ltd. & M/s Shikhar Housing Development Pvt. Ltd. was conducted on 27th July 2013 to resolve the issue of violation committed by the company pertaining to EIA Notification 2006 and its provisions. The matter of violation was placed before the management. Following was brought to the notice of the management.

1. The company has applied Air/ Water Consent from M.P. Pollution Control Board Bhopal.
2. That, it was brought to notice of management that any project comprising construction activity of more than 20000 m² requires prior Environmental Clearance under the provisions of EIA notification, 2006 from competent authority.
3. In light of the above management should have applied and obtained prior EC for any construction of more than 20000 m² the same has not been obtained for our project in question which is violation of the provisions of EIA notification and punishable under EP (Act) - 1986.



That, now an application along with the requisite documents has been submitted with SEIAA for obtaining EC. The management has taken the issue seriously and reviewed and discussed the environment related policy of the company exhaustively. The only violation observed is that of the provisions of EIA Notification 2006.

Taking into account the above facts the management passed the following Resolution & Undertaking.

The company should have applied and obtained prior EC immediately after planning for construction of more than 20000 m² and construction activity was taken without obtaining the same for our project in question which is violation of the provisions of EIA Notification and punishable under EP (Act) - 1986. With this undertaking the company extend its sense of apology for committing such violation. However violation was made unknowingly & non intentionally, now an application along with requisite documents has been submitted with SEIAA for obtaining EC. The company is now well aware of all the Environmental legislations. It is also submitted that such violation will not be repeated by the company in future. Any construction activity in the project shall be taken up only after obtaining due environmental clearance from competent authority.
