With reference to the aforementioned subject, it is hereby submitted that our organization while executing the activities in our project on "Moja Talavali Chanda Tehsil & Distt, Indore Madhya Pradesh.", initiated the construction and other miscellaneous activities without obtaining prior EC under the provisions of EIA Notification since we planned to construct only 18000 Sqm approximately which was outside the purview of said EIA Notification. In fact, the Management was not fully aware of the salient features of the EIA notification; the Management has taken the issue seriously and apologizes for the same. Now as our Management is aware of the said provisions we have applied to MPSEIAA for obtaining Environmental Clearance.

We have learnt from the Office Memorandum No. J-11013/41/2006-IAII (I) of Government of Ladia Ministry of Environment & Forests dated 12th December, 2012 that our case for EC shall be considered by the SEIAA/SEAC only after credible action for above violation is initiated by the concerned authorities. Hence it is requested to take necessary credible action in the context so that our application for prior EC may be taken up for further necessary action by the SEIAA/SEAC. Resolution Passed by the Management in this regard is being submitted to SEIAA and a copy of the same is enclosed herewith.

Mr. Tarun Kathuria, Director of the Company informed the Board Members about the mistake committed inadvertently by the Company by starting construction of Group Housing Project situated at Village Mouza Talawali Chandra District, Indore without seeking prior Environment Clearance under the Environment Impact Assessment Notification (EIA), 2006 and its amendment thereafter and in reference there to the Office Memorandum dated 16th November, 2011. He further informed the Board that the mistake occurred as initially the area planned to be constructed for the Group Housing Project was approx. 19000 sq. mtrs. which did not require Environment Clearance. Subsequently, the area for construction was increased to more than 20,000 sq. Mtrs which led to violation of Notification dated 14th September, 2006 under the Environment Protection Act, 1986.

The Board Members discussed the matter in detail and the following Resolution was passed.

*RESOLVED THAT the Board of Directors do humbly submit that the initially construction activities of Group Housing Project at Village Mouza Talawali Chandra District, Indore planned were approx. for an area of 19,000 sq. mtrs which did not require grant of Environment Clearance under the Government Notification dated 14th September, 2006 under the Environment Protection Act, 1986.

RESOLVED FURTHER THAT the area planned for construction of the aforesaid project was subsequently increased to more than 20,000 sq. mtrs. which led to omission of seeking Environment Clearance under the provisions of Environment Notification dated 14th September, 2006 under the Environment Protection Act, 1986.

RESOLVED FURTHER THAT the omission occurred inadvertently because of the above and that the Board of Directors express their sincere regret on this mistake (which amounts to violation of the Environment (Protection) Act, 1986) and resolve to assure the SEAC, M.P. that this mistake would not occur again.

RESOLVED FURTHER THAT the Board of Directors do assure the SEAC, M.P. that they will fully comply with all the general and specific conditions envisaged by the Hon'ble SEAC, M.P.

RESOLVED FURTHER THAT the Board do inform SEAC, M.P. that adequate steps shall be incorporated into the Environment Management Plan and any other conditions put forth by the SEAC, M.P. will be fully complied with.
