**Sub:-Case No. - 1509/2013**, Prior Environmental Clearance for **Metal Stone Quarry** (Opencast Semi-Mechanised Method) in an area of 3.220 ha. for production capacity of 75,000 cum/year (as per approved mining plan) at Khasra no. 17 at Vill. Lakhanpur, Tehsil- Dabra, District-Gwalior (M.P) by M/s Rituraj Stones Pvt. Ltd., Director Shri Amarjeet Singh Kushwaha, 336, Tansen Nagar Gwalior (MP)-474004.

The case was discussed in 270<sup>th</sup> SEIAA meeting dtd 14.12.15 and it has been recorded that .....

- (1) It was noted that M/s Rituraj Stones Pvt. Ltd., 336, Tansen Nagar Gwalior (MP)-474004 (**Transferee**) has requested to transfer the above Prior Environmental Clearance (EC) in their name.
- (2) It was found in record that the Prior EC was granted for the lease period vide L.No. 6075/SEIAA/15 dtd. 07.10.2015 in the name of Smt. Neerja Maraiya, K-8, Gandhi Nagar, Tansen Road, District-Gwalior (M.P.)-474002.
- (3) The transferee, M/s Rituraj Stones Pvt. Ltd. has submitted the following documents in support of his request:
  - (i) NOC from the transferor (Smt. Neerja Maraiya).
  - (ii) Consent of Transferee (M/s Rituraj Stones Pvt. Ltd.) to abide by the terms & conditions of the EC letter.
  - (iii) Consent of Collector, District Gwalior (M.P).
- (4) "In this regard it was noted that in EIA Notification 2006 as per Para-11 Transferability of **Environmental Clearance (EC)** there is a provision of transferring the EC.

**Para - 11:** A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above, it was decided that the Prior EC may be transferred in the name of M/s Rituraj Stones Pvt. Ltd., 336, Tansen Nagar Gwalior (MP)-474004 (**Transferee**) with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period."

Hence, it was decided to transfer the Prior EC in the name of M/s Rituraj Stones Pvt. Ltd., Director Shri Amarjeet Singh Kushwaha, 336, Tansen Nagar Gwalior (MP)-474004 with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
