

# 1. INTRODUCTION

By notification of the Government of India, Ministry of Environment, Forest and Climate Change, published in the Gazette of India, Extraordinary, Part II Section 3 sub section (ii) dated 15<sup>th</sup> January, 2016 directions have been given regarding the preparation of District Survey Report of minor minerals of each district. The Ministry of Environment, Forest and Climate Change has amended the said notification vide S.O. 3611 (E) dated 25<sup>th</sup> July, 2018 in which the procedure for preparation of District Survey Report for each minor mineral (other than sand) has been prescribed.

With reference to the above-mentioned order of the Directorate Geology and Mining Madhya Pradesh order no. 11920/geology/2020 Bhopal Date 22-10-2020 and order no.2981/khanij/Vividh/2022 Bhopal Date 03-03-2022 the district survey report of minor mineral of district Bhopal is prepared. The main objective of district survey report is to identify the mineral resources and mining activities along with other relevant data of the district and to identify the areas of aggradation/ deposition where mining can be allowed and identification of areas of erosion and proximity to infrastructural structures and installations where mining should be prohibited, calculation of annual rate of replenishment, etc. This report is based on the basis of data collected from different concerned departments, mining plans etc.

Bhopal is a district of Indian state of Madhya Pradesh. The headquarters of the district is Bhopal which is also the state capital. Guna district in the north of Bhopal district, Vidisha district in North-Eastern, Raisen district in the east and south-east, Sehore district in south and south-west and Rajgarh district in north-west. Bhopal district, spanning over an area of about 2772 km<sup>2</sup>, lies in the central part of the state of Madhya Pradesh. The district lies between North latitude 23°05' and 23°54' and east longitude 77°10' and 77°40' falling in Survey of India Toposheet No. 55 E.

## 2.OVERVIEW OF MINING ACTIVITY IN THE DISTRICT

Bhopal district is floored by rocks of Vindhyan supergroup, the Deccan trap and quaternary laterite and alluvium. The Vindhyan supergroup mainly include sedimentary rocks. The Deccan traps rocks are the main source of road metal in the district, weathering of these rocks results in formation of murrum. Laterite occurs as isolated cappings over the Deccan trap. Weathering and accumulation of fragments of laterite and the subsequent consolidation have given rise to secondary laterite, at several places. Alluvium occupies the river valleys and plains and belongs to the older alluvium and younger alluvium. It mainly consists of sand, silt and subordinate amount of clay.

No mine of major mineral is found in Bhopal district. Bhopal district is quite rich in Stone used as road metals. There are mines and quarries of minor minerals like Road metal (Gitti), Murrum and Sand (Bajri) in the district. There are 140 quarries of Stone and 27 quarries of murrum in the district. Maanpura and Ghogalpur sand mines are the only mines of sand (bajri) auctioned through e tender process in the district which covers an area of 10.00 hectare. Quarry lease of mineral Stone (gitti) covers 407.501 hectare and Quarry lease of mineral murrum covers an area of 54.41 hectare in the district.

In last five financial years the revenue received by mining department in Bhopal is rupees 83.74 crores .In financial year 2021-2022 revenue received by mining department Bhopal district is rupees 17.13 crores.

## 4. GEOLOGY OF THE AREA

Bhopal district covering an area of about 2772 sq.km is situated in the central part of Madhya Pradesh, in the Survey of India Toposheet no. 55E. The topography of the district is highly rugged and undulating comprising hills, dissected plateaus, valleys and flats.

The area forms part of Betwa sub basin of Yamuna master basin, and is drained by Parbati, Bean, Halali, Kolans, Kaliasot and Kerwa rivers.

The upland region belonging to the main Vindhyan hill range is characterized by NNW-WSW and ENE-WSW trending hills range which subdivide the district into two physiographic units, one north and the other south of Bhopal city. The northern unit is characterised by gentle slope and the southern by relatively steeper slope. Lineaments and structural features like fractures/ joints and faults have critical role in shaping the drainage.

Bhopal district is floored by rocks of Vindhyan supergroup, the Deccan trap and quaternary laterite and alluvium.

The vindhyan supergroup mainly include sedimentary rocks. The oldest litho-sequence belongs to the Upper Rewa Sandstone, locally designated as Nawarganj sandstone. It comprises thinly bedded to flaggy off white, medium to coarse grained sandstone exhibiting well developed cross bedding. This litho unit forms low linear ridges south of Bhopal. The overlying Bhandar group is represented by Lower bhandar sandstone, Sirbu shale and Upper Bhandar sandstone. The upper Bhandar sandstone is locally designated as Nurganj sandstone. The rocks of the vindhyan supergroup host well developed sedimentary structures like bedding, cross bedding, ripple marks, ribs and furrows, flute and load cast, mud cracks and clay galls.

Deccan traps basalts flows occupy vast areas in the north, central and western parts of the district. They have been classified into three formations viz. Kalisindh, Kankariya-

Birukhedi and Indore based on diagnostic characters and markers horizons or intertrappeans beds.

Laterite occurs as isolated cappings over the Deccan trap in the north, central and western part of the district. The general level of occurrence of the laterite capping is 500m above m.s.l. weathering and accumulation of fragments of laterite and the subsequent consolidation have given rise to secondary laterite, at several places.

Alluvium occupies the river valleys and plains and belongs to the older alluvium and younger alluvium. Older alluvium mainly comprises of yellow, grey, reddish brown clays with gravels horizons. Younger alluvium is confined to the present day flood plains of the major rivers and streams. It mainly consists of sand, silt and subordinate amount of clay.

The main economic minerals in the district are bauxite, clay, ochre, glass sand, iron ore and calcite, but these are not of economic importance because of restricted occurrences. Sandstone of the Vindhyan super group forms a source of building stone in the district. Massive basalt of the Deccan trap is used for constructional purpose and as road metal.




### DrainagePattern

### IrrigationPractices

Irrigation is the artificial application of water to the soil for normal growth of plants. Water is an important determinant factor for production of crops in agriculture sector. Intensive and extensive cultivation of land depends mainly on the availability of water. Medium and minor irrigation schemes are implemented in the state for augmenting the water supply for agriculture. The various sources of irrigation in Bhopal district are canals, tanks, tube wells, bore wells, dug wells etc. As per the district ground water information booklet year 2013, total net and gross irrigated area in Bhopal district is 887 Sq.km.



## 7. SCENARIO OF SURFACE WATER AND GROUND WATER IN DISTRICT

### Ground Water

Ground Water is found beneath the earth's surface and is an important source of water in most of the Districts in the State. Ground Water is withdrawn for Agriculture, Municipal and industrial use. The depth at which the groundwater occurs is called Groundwater Table.

Variation of groundwater levels in an area is an important component of hydrological cycle because it is a physical reflection of aquifer systems. As the change in groundwater level is directly related to groundwater balance and its continuous records provide direct information of subsurface geo-environmental changes due to withdrawal of groundwater.


The pre-monsoon depth to water level in Bhopal district ranges between 5.15 m bgl at Balrampur ghati to 18.4 m bgl at Islamnagar in Phanda block. The most part of both blocks of the district have water level in the range of 10-18 m bgl during the pre-monsoon. The northern part of district in Berasia block and eastern part of district in Phanda block have the water level in the range of 5-10 m bgl. During post-monsoon period, the water level ranges from 1.24 m bgl at Balrampur ghati to 11.61 m bgl at Islamnagar. It is observed that in most part of the district the water level lies between 5 to 10 m bgl during this period. In the central part of Phanda block the water level lies between 10-13 m bgl. However, in the eastern part of Phanda block and southeastern part of Berasia block the water level lies between 0.5-6 m bgl. A comparison of pre-monsoon water level data with the post-monsoon water level data reveals that there is rise of water level in entire district during post-monsoon (0.02-2.5 m/year rise) while fall during pre-monsoon (0.08-0.37m/year fall).

## 8. CLIMATE AND RAINFALL CONDITION OF DISTRICT

### Climatology

The climate of Bhopal district is characterized by a hot summer and well-distributed rainfall during the southwest monsoon season. The year can be divided into four seasons. The winter commences from middle of November and lasts till the end of February. The period from March to about first week of June is the summer season. May is the hottest month of the year. The southwest monsoon starts from middle of June and lasts till end of September. October and middle of November constitute the post monsoon or retreating monsoon season. The climate of the Bhopal district is classified by the Thornthwaite precipitation effectiveness method. It is based on the assumption that total monthly rainfall and temperature determine the climate. The annual precipitation effectiveness of the district is 63.7, which indicates that the climate in the district is humid and forest type vegetation.

### Temperature

The temperature starts rising from the beginning of February and reaching maximum in the month of May. The normal daily mean monthly maximum temperature is 40.7°C and daily mean minimum temperature is 25.3°C. The individual day maximum temperature in May goes up to 44°C. The individual day minimum temperature is recorded 10.2°C in the month of January. The summer season is the driest period of the year. The humidity comes down lowest in April. It varies between 26% and 88% at different times in different seasons. The wind velocity is high during the monsoon period as compared to pre and post monsoon. The wind velocity is highest in June around 18.9 km/hr and lowest is 7.0 km/hr in November.

## Rainfall

On the basis of Bairagarh and Berasia rain gauge stations data, the average annual rainfall of Bhopal district is about 1126.7 mm, while based on IMD station at Bairagarh; the annual normal rainfall of Bhopal is 1260.2 mm. Bhopal receives maximum rainfall during southwest monsoon period. About 92 % of the total rainfall takes place only during the monsoon period. The maximum rainfall (about 39 %) takes place during the month of July. In winter occasional rainfall of about 6 % takes place. During summer only about 2 % of the annual rainfall takes place. Thus, from October to middle of June only about 8 % of the annual rainfall takes place.



## 14. MINERAL RESOURCES AVAILABLE IN DISTRICT.

Bhopal district is floored by rocks of Vindhyan supergroup, the Deccan trap and quaternary laterite and alluvium. The Vindhyan supergroup mainly includes sedimentary rocks. Sandstone of the Vindhyan super group forms a source of building stone in the district. Massive basalt of the Deccan trap is used for constructional purpose and as road metal. Weathering of these rocks results in formation of murrum.

Some economic minerals available in the district are bauxite, clay, ochre, glass sand, iron ore and calcite, but these are not of economic importance because of restricted occurrences.

No mine of major mineral is found in Bhopal district. Bhopal district is quite rich in Stone used as road metals. There are mines and quarries of minor minerals like Road metal (Gitti), Murrum and Sand (Bajri) in the district.

Presently, Quarry lease of Stone (Gitti) Derived from Deccan trap basalt are sanctioned in and around Ratuaratanpur, Chandbadkadim, Pardi, Hinotisadak, Netapura, Kolukhedikalan, Runaha etc villages in Berasia tehsil of Bhopal. In Huzur tehsil, stone gitti leases are sanctioned in and around Neelbad, Sikandarabad, Sarvar, Chappari, Barkhedanathu, Malikhedi, Kalkheda etc. Some are sanctioned and operating near Ratatal, Shahpur, Rasuliya Pathar, Parvaliyasadak, Barkheda bondar villages and some in their neighbourhood villages. Murrum lease are sanctioned in Tumda, Rajeev nagar, Manikhedikot, Mugaliyachaap, Tanda etc villages. As per the data derived from mining plan and mining scheme of sanctioned quarry leases of Bhopal district, the total geological reserve of Stone is 30339925 cubic meter and geological reserve of Murrum is 2048649 cubic meter.

As per field observations, huge deposits of Deccan trap Basalt are found at Baandikhedi village which may be a source of Road metal to meet future requirements. Stone of medium quality are also found near Netapura and Bhaatni Villages. Some of the mineral potential areas of murum are Islamnagar, Acharpura, Mastipura, Bagoniya, Khauri, khurchani, Chanderi, Rolukhedi, Baalampur, Mugaliyachaap, Suhaagpur, Purachinndwara, Shekhpura, Tumda (Rajeev Nagar) etc in Huzur and kolar Tehsil. As per primary field observations Keetkhedi, Basai, Barri, Chakpipalkheda etc in berasia tehsil are the areas where murum is available



## 21. IMPACT OF MINING ACTIVITY ON ENVIRONMENT (AIR, WATER, NOISE, SOIL, FLORA, FAUNA, LAND USE, AGRICULTURE, FOREST ETC)

Environmental impacts of mining can occur at local, regional, and global scales through direct and indirect mining practices. Impacts can result in erosion, sinkholes, loss of biodiversity, or the contamination of soil, groundwater, and surface water by the chemicals emitted from mining processes.

### 1- Air

Mining activities such as crushing and blasting of stone, removal of top soil and extraction of weathered material Murrum may cause release of large amount of dust in the air. Similarly movement of minerals in large vehicles without any protective measure can cause air pollution and respiratory problems.

### 2- Water

Mining can have harmful effects on surrounding surface and groundwater.

### 3- Noise

Mining activities such as crushing and blasting of stone, removal of top soil and extraction of weather material murrum through heavy machinery and crushing plants produce heavy noise in the surrounding areas.

### 4- Soil

Movement of Rocks due to mining activities and movement of over burden in case of Flagstone and boulder mines cause a large impact on soil. It causes erosion of soil and degradation of land.

## 5- Flora, fauna

Mining activities adversely affect the flora and fauna in local and regional level. Some time large number of plants and trees are cut before the extraction of mineral. Similarly heavy sand mining in rivers cause change in eco system of river aquatic life.

A Mining activity may land use pattern area for example extraction of minerals from mountain and hills degrade the beauty of mountains, Agriculture land changes to barren land due to mining activities in nearby areas. ## 22. MEASURE FOR REDUCING IMPACT OF MINING ACTIVITIES ON ENVIRONMENT.

- The mining shall be carried out strictly in accordance with the M.P. minor mineral rule 1996, M.P. Sand (Mining Transportation, Storage and Trading) Rule- 2019, Sustainable Sand Mining Management Guidelines, 2016 and Enforcement & Monitoring Guidelines for Sand Mining, 2020 issues by the MoEF&CC ensuring that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations.
- Impact of mining activity on environment may be reduced by any lessee by following the terms and conditions given by pollution control board as per Water (prevention and control of pollution) Act- 1974 and Air Water (prevention and control of pollution) Act- 1981 and by following the specific and standard condition recommended by environmental impact assessment authority.
- Mining should be carried out as per the mining plan approved by authority so that impact of mining activity on local environment may be reduced.
- Air pollution in areas where crushing units are established may be reduced by frequent sprinkling of water in lease area and approach roads. In Stone crushing unit water sprinkler, wind breaking wall, GI sheet-sheds should be installed.
- Thick plantation should be carry out in and around the quarry areas. Waste generated due to mining activity should be properly dumped and reuse.
- Protective measures such as respiratory devices, N-95 Mask should be provided to mine workers to reduce the air pollution. Similarly Ear Plugs should be provided to mine workers to reduce the Noise pollution.
- It should be frequently monitor that mining of sand in river beds does not change the natural flow of river water. It helps in maintaining the water resource.

## 23. RECLAMATION OF MINING AREAS

Quarrying operations in general has adverse environmental effects if proper abatement measures are not taken. As a result of mining operation the original land profile will obviously altered and the magnitude and significance of environmental pollution caused by mining depends on type of available minerals, method of mining & processing etc.

Reclamation and rehabilitation of mined out land are the most important post mining activities. These practises will commence only after the excavation of optimum thickness of stone which is economically viable.

For reclamation and land the mining activity should be plan according to the mining plan so as to provide the early back filling and reclamation of the mining.

In some quarry lease reclamation of mines can be done by back filling the waste rock or over burden into the quarry after the period of quarry lease is over. Though a reclamation a mine or quarry reclamation plan must contain the following steps.

- 1- Storage and preservation of top soil/over burden.
- 2- Proposal for reclamation of land affected by mining during and at the end of mining.
- 3- Stabilisation and vegetation of dumps.
- 4- Preparation of dumping ground for stacking mineral substance.

In most of the cases, availability of waste at the closing time of mine will be very less to meet requirements for backfilling, hence in such cases the mined out pit will be developed as water reservoir in future. The quarry pit should be fenced by barbed wire to prevent inherent entry of public and cattle. The quarried out pit will be allowed to collect rain and seepage water which acts as a reservoir for storage.



## 24. RISK ASSESSMENT AND DISASTER MANAGEMENT

In Bhopal district, as there are only mines of minor minerals and mining activities carried out are open cast semi mechanized type thus no high risk accidents are anticipated. However in case of quarries of depth more than 5 meters, mine engineer and mine managers are recruited as per Madhya Pradesh minor mineral rule 1996 to avoid any risk of accidents. The quarry pit is fenced by barbed wire to prevent inherent entry of public and cattle. No mining should be undertaken during monsoon period to avoid accidents.

## 25. PLANTATION AND GREEN BELT DEVELOPMENT RELATED TO PRIOR LEASE IN DISTRICT

During mining operations green belt development through plantation is most important for environment safe guard, which should be supervised by related departments frequently. Different type of species should be planted near lease periphery to keep environment clean at post mining period through reclamation. Where specific usefulness of land could be decided, a forestation is normally planned through the site could have been considered for better possibilities of land use.

Every year plantation is done by each quarry lease holder in the district near and around the lease area. However, only few plants survive every year because of lack of maintenance and due to unfertile area in and around mining areas. Thus there is need of demarcation of areas that can be reserved for plantation by quarry lease holders of the district.




## 26. DETAILS OF OCCUPATIONAL SAFETY ISSUES IN THE DISTRICT(SILICOSIS AND TUBERCULOSIS), IF ANY

The persons employed in the mines are exposed to a number of hazards at work which adversely affect their health. Some of the important ones are dust, noise, heat, humidity, vibration etc. In recent times, there has been increasing awareness among mining industry about the workers about occupational diseases, caused by exposure to health hazards at work. Many of these occupational diseases cause permanent disablement and there is no effective treatment. However, most of the occupational diseases can be prevented by adopting proper occupational health measures and engineering control on airborne dust at workplace. Silicosis, Tuberculosis, Noise induced hearing loss, Cancer of lung, contact dermatitis etc are major health issues originated in mining areas. However, No such case of Silicosis and Tuberculosis are detected till date in Bhopal district.


